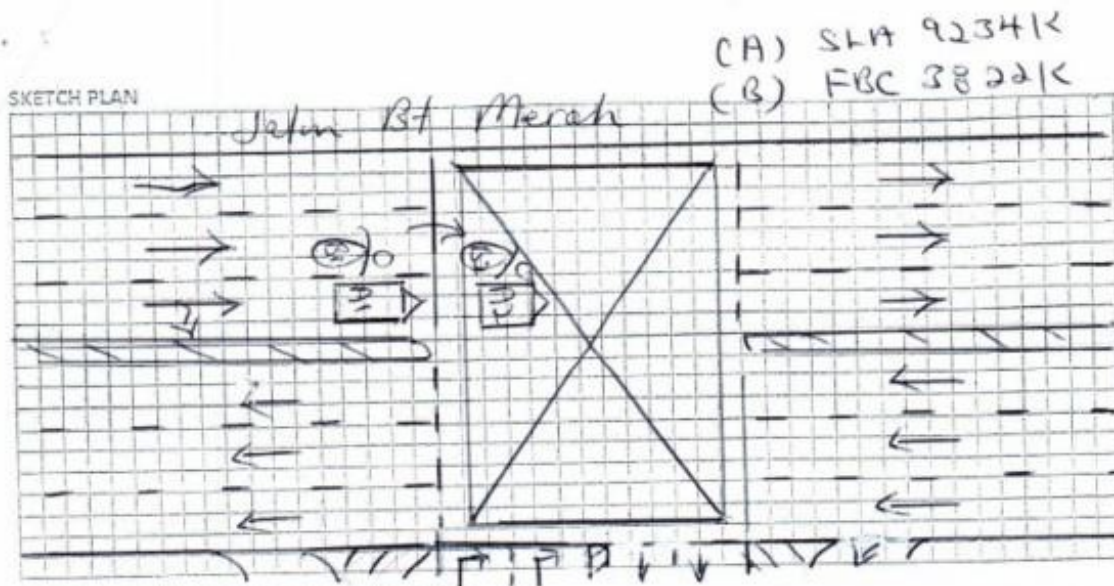

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 25/01/2019 at about 2200 hrs at along Jalan Bukit Merah towards CTE Junction of College Road.
