Accident Sketch Plan

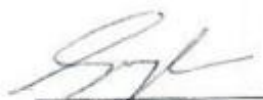

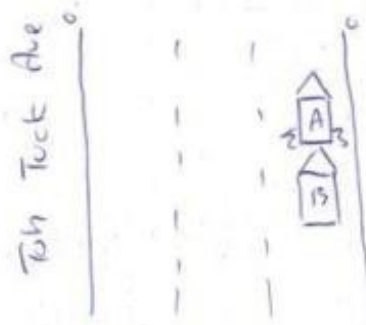
