WHEN ABOUT TO REACH JUNCTION OF TAMPINES AVENUE 4, I CHECK ON BLIND SPOT BEFORE CHANGE TO 3RD LANE. SUDDENLY A CAR NO. SKR9029J MAKE A SUDDEN BRAKE. WHEN I NOTICED, I APPLIED MY BRAKE BUT FAILED TO STOP ON TIME AND RESULTED MY CAR COLLIDED TO REAR PORTION OF SKR9029J. 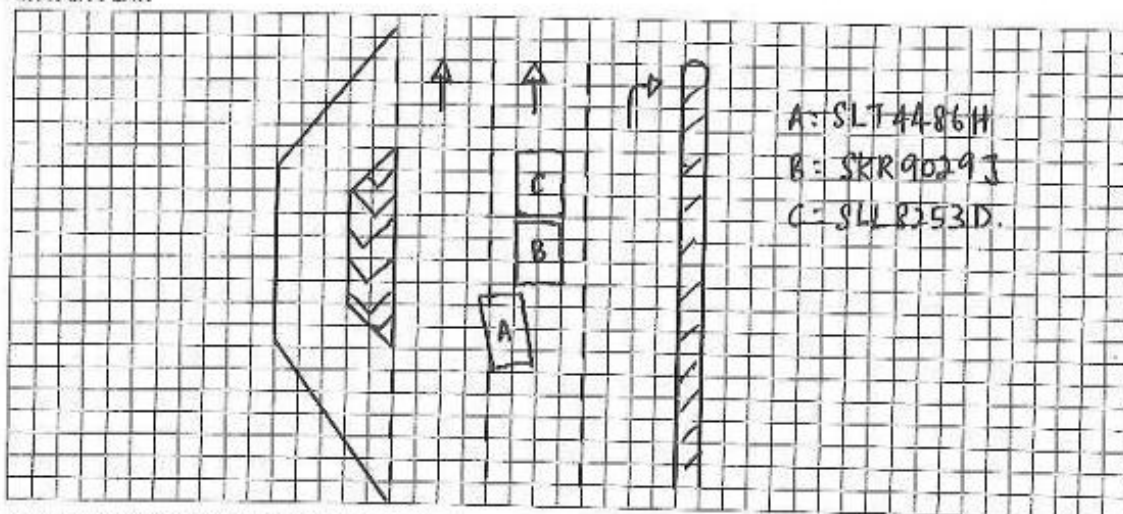

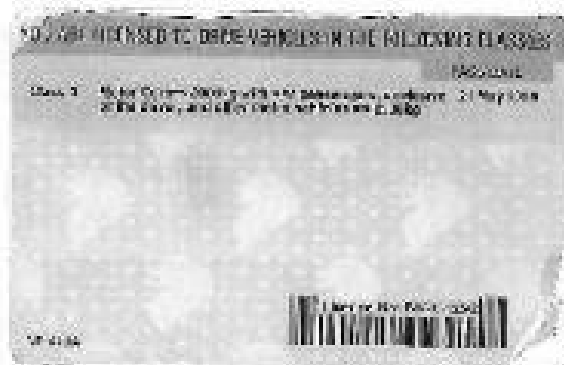
