hit into his car's rear portion.





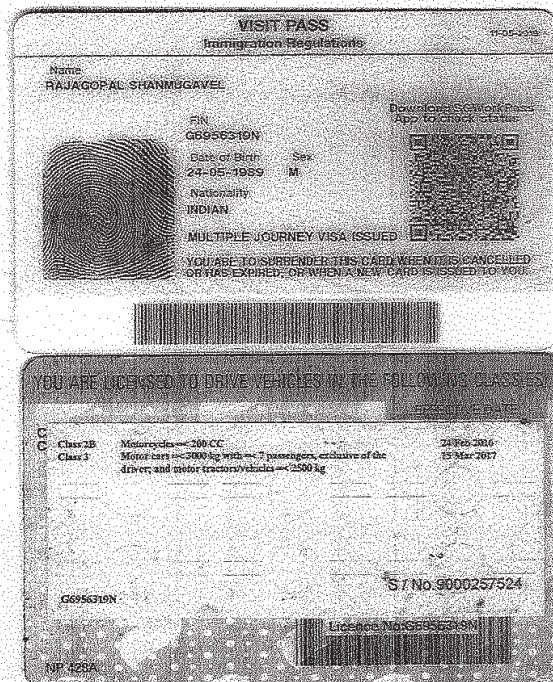
