



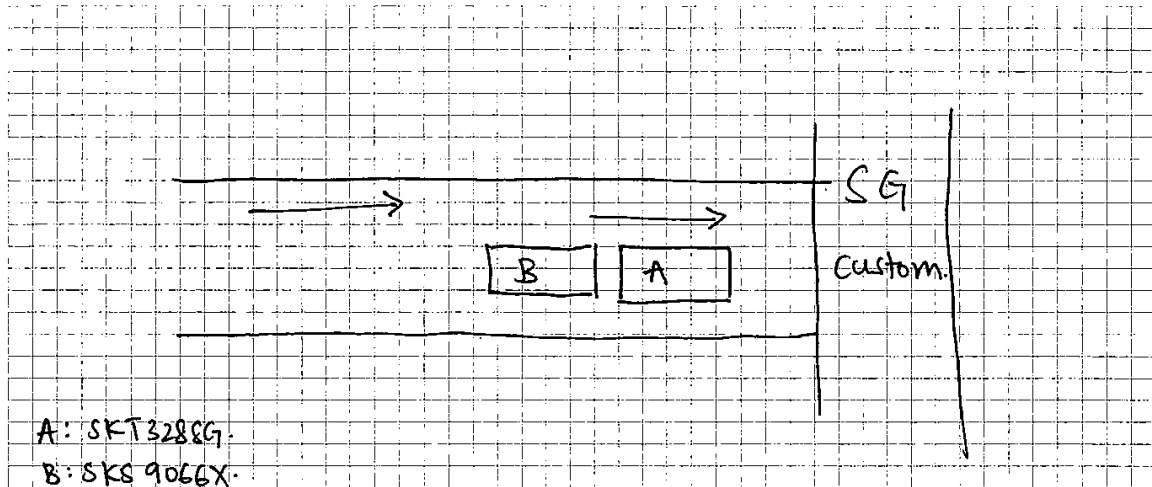

SKETCH PLAN





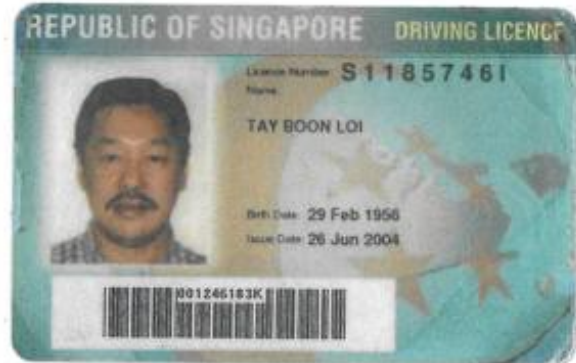
