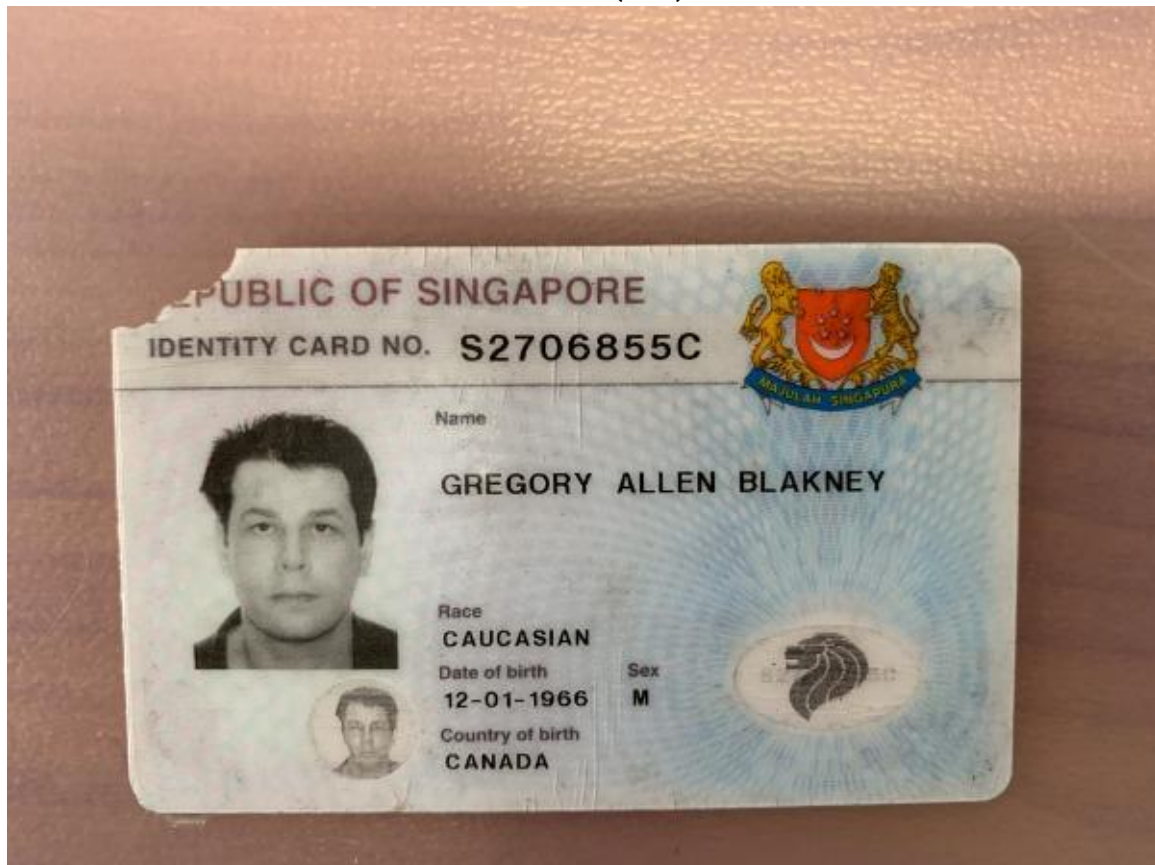

Sketch Plan



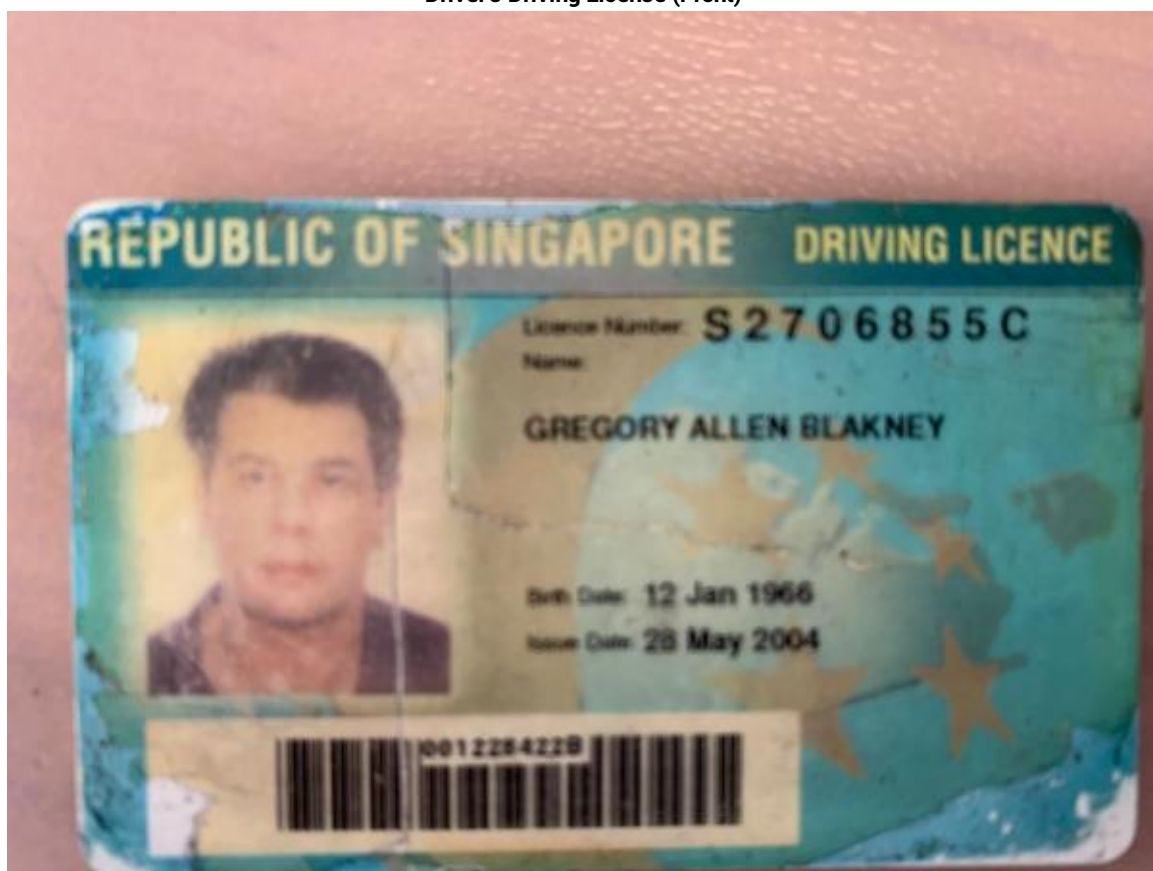
Driver's Nric (Front)
