#straightroad Moving straight & Moving straight SJT3931U SLC9185H WSVC19000108 Accident\_Description Traffic was smooth along Clementi Road heading towards Upper Bukit Timah Road. My vehicle was on the right-most lane heading onto Jln Anak Bukit (on Bukit Timah Seven Mile Flyover) opposite Bukit Timah PLaza when the car in front of mine slowed and applied its brakes. I managed to slow and stop my vehicle in time. However the vehicle behind mine (SJT 3931U) could not stop in time and attempted to swerve left but was unable to avoid a collision with my vehicle. After the collision we did not exit our vehicles but proceeded to the nearest location (Esso petrol station on Upper Bukit Timah Road) where we could park safely to inspect the damage and exchange particulars.
