DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving home with my family on Jan 25th, 2019 at around 8:30pm. I was in the left lane on New Bridge Road, intending to turn left onto N. Canal Road. Traffic was heavy due to Chinatown CNY jam. The double-decker bus in front of me stopped and I stopped as well. Then I heard a loud bang and saw a taxi, SHC 5980C, had smashed into my right rear side. The accident happened just before the traffic light junction but I recalled traffic light was green but we were not moving due to the jam. The taxi driver was likely rushing to pick-up a nearby passenger as I noticed he didn't have any passenger.

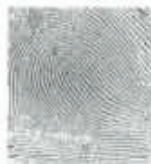

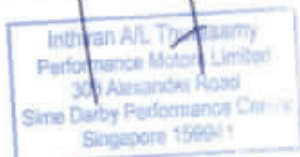
