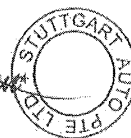


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


After returning from the loo, I was informed by driver of SL830013, that SMF 2338C had rolled forward and hit the back of SL830013.

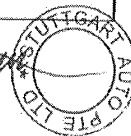
