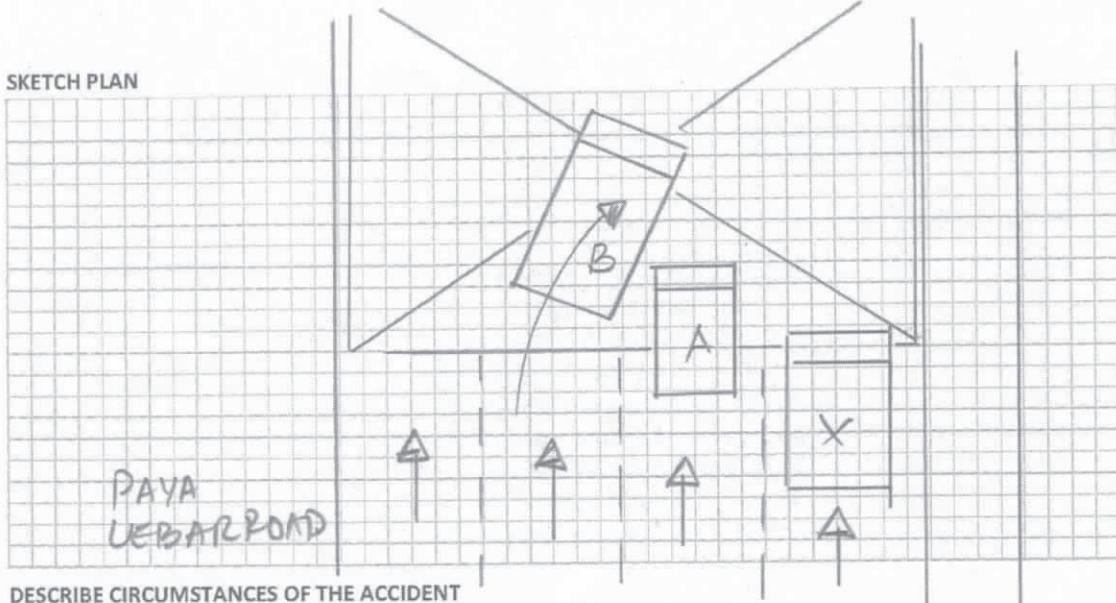

Describe Circumstance of the Accident.

ON 31/01/2019 @ 1230 HRS, I WAS DRIVING MY TAXI (SHB 8856 P), TRAVELLING ALONG PAYA LEBAR ROAD TOWARDS GULLIEMARD ROAD WITH 2 PASSENGERS ONBOARD, IN LANE 2.

I STOPPED MY TAXI BEFORE THE YELLOW BOX JUNCTION – AS VEHICLES AHEAD WERE STATIONARY.

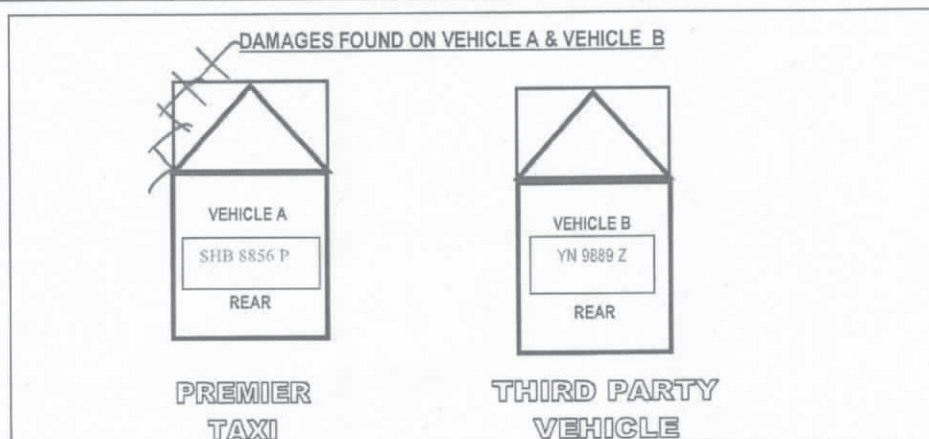
AS VEHICLES AHEAD STARTED TO MOVE OFF, I FOLLOWED SUIT – MOVING OFF SLOWLY BUT SUDDENLY VEHICLE B (YN 9889 Z – LORRY) WHICH WAS FROM LANE 3 – FAILED TO KEEP FOR PROPER LOOK OUT & FAILED TO OBSERVE FOR CLEARANCE FROM MY ROUTE – HAD ENCROACHED ONTO MY PATH ON MY LEFT FRONT ABRUPTLY.

AS SUCH, THE RIGHT PORTION OF VEHICLE B COLLIDED ONTO THE LEFT FRONT FRONT OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE LEFT FRONT PORTION & NO DAMAGES TO VEHICLE B.
