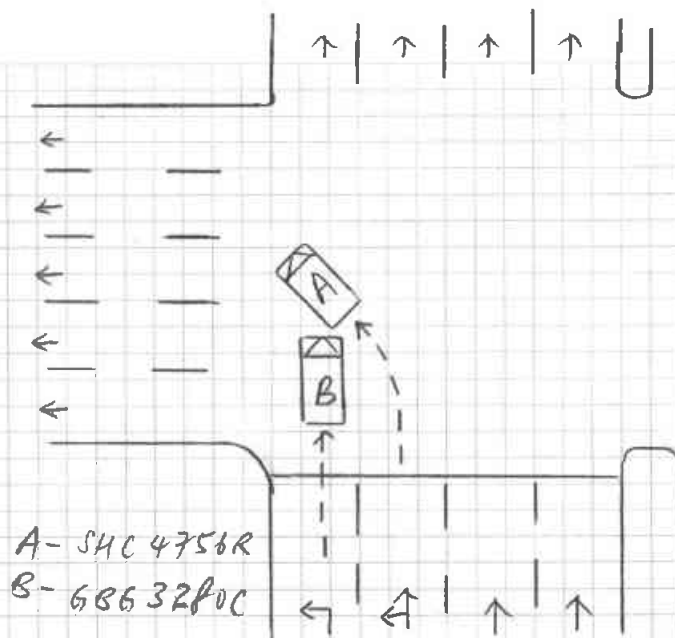

I WAS TRAVELLING ALONG SHEARES AVE AT THE SECOND LEFT LANE WITH A PASSENGER ON BOARD. UPON REACHING THE TRAFFIC JUNCTION, TRAFFIC LIGHT WAS GREEN AND THUS I PROCEEDED TO MAKE A LEFT TURN INTO MARINA BOULEVARD. WHILE TURNING, SUDDENLY THE LORRY GBG3280C FROM THE LEFT MOST LANE (LEFT TURNING ONLY LANE) INSTEAD OF TURNING LEFT, HE MOVED STRAIGHT AND COLLIDED ONTO THE REAR LEFT PORTION OF MY TAXI.
