My family could smell burning smell coming from underneath our vehicle and thus got off the vehicle. I then happened to see a patrolling police car travelling pass us and thus waved towards the police vehicle. The police car then stopped and tried to assist us to pull out the mattress but to no avail. After a few minutes, the mattress caught fire. The policemen tried to utilize 2 fire extinguisher to put out the fire but failed. Later, the vehicle engulfed in flames. Two fire engines from SCDF then came down and managed to douse the fire.
