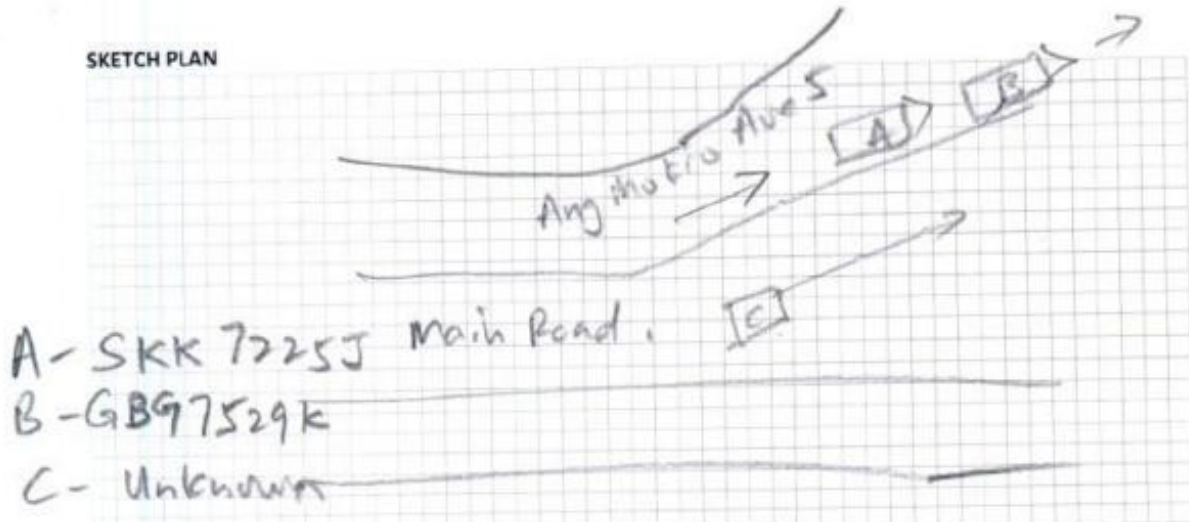

SKETCH PLAN




- A - SKK 7225J Main Road.

- C - Unknown


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT



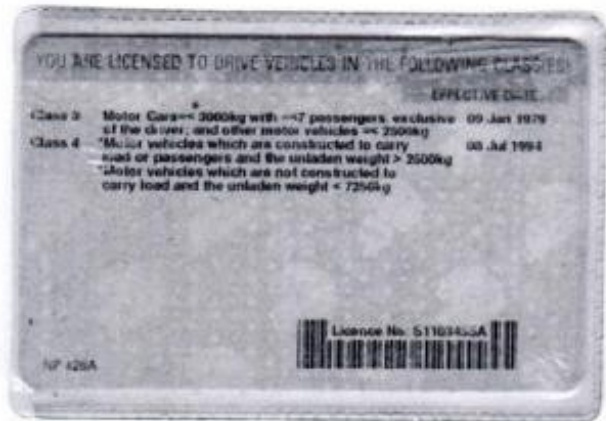
