Lodged at Traffic Police Division HQ Brief Details ON THE ABOVE MENTIONED DATE AND TIME I WAS DRIVING ALONG JALAN BESAR IN MY VEHICLE s1s2826d, ON THE 2ND LANE FROM THE RIGHT. THE TRAFFIC WAS SLOW AND THERE WAS NO RAIN. THERE WERE VEHICLES PARKED ALONG THE 1ST LANE AND A TAXI BEARING THE PLATE NUMBER SHC5192K WAS ALSO ALIGHTING A PASSENGER ON THE 1ST LANE. BECAUSE OF THE SITUATION ON THE 1ST LANE, MOST OF THE MOVING VEHICLES WERE TURNING FROM THE 2ND LANE THAT I WAS ON SO I FOLLOWED TRIED TO MAKE THE TURN ONTO MUSTAFA BY THE 2ND LANE. JUST AS I WAS ABOUT TO MAKE THE RIGHT TURN ONTO MUSTAFA , SHC5192K MOVED FORWARD AGGRESSIVELY, SCRATCHING THE RIGHT SIDE DOOR OF MY VEHICLE. AFTER THE COLLOSION, THE DRIVER CAME OUT OF HIS VEHICLE AND STARTED SCREAMING AT ME. I TRIED TO ASK THE DRIVER TO EXCHANGE PARTICULARS BUT HE REFUSED TO EXCHANGE PARTICULAR WITH ME. I THEN CALLED MY CAR TECHNICIAN TO FIND OUT WHAT TO DO ABOUT DRIVERS WHO REFUSE TO EXCHANGE PARTICULARS. MY TECHICIAN THEN INSTRUCTED ME JUST TAKE PHOTOS AND VIDEO OF THE ACCIDENT AND I CAN LEAVE THE SCENE TO SETTLE THE CLAIMS THE NEXT DAY. 


