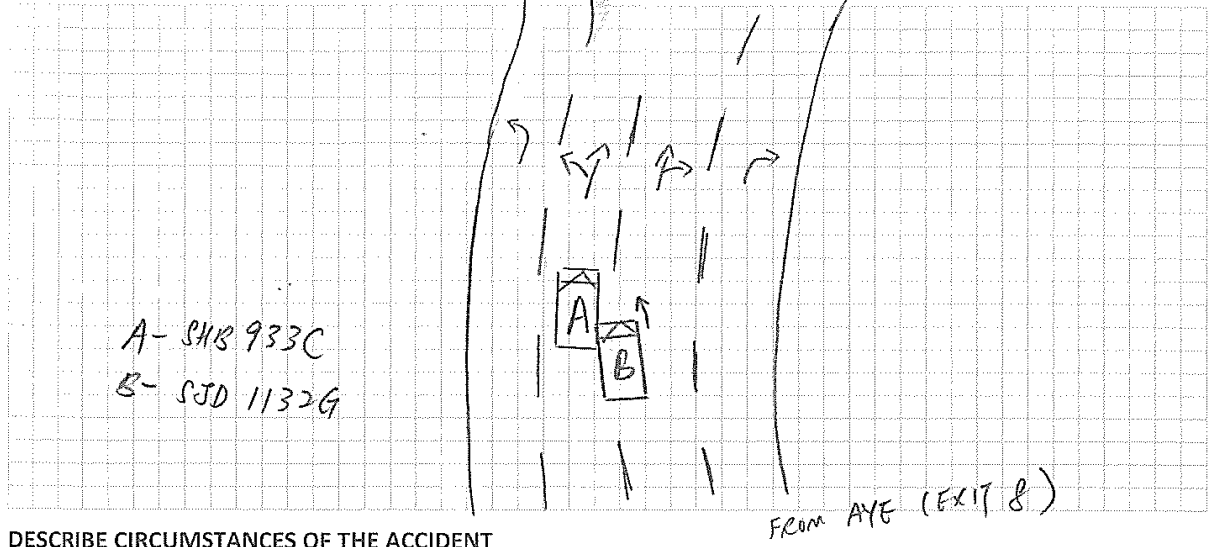

SKETCH PLAN

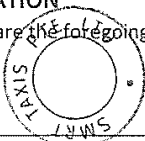
