Brief Details.

On 24/01/2019 around 1430hrs, I was travelling along Upper Bukit Timah Road on the first lane out of a four lane road. I was travelling in my car (SLA7404A) with my wife seated on the front passenger seat while my 8 year old daughter was seated in the rear passenger seat and she sat behind me.

After I was travelling down the road, I noticed a black Citroen car, cutting across all four lanes. The car had taken the exit at the bend near Courts. As I noticed this, I stopped my car in order to prevent any collision. When my car came to a full stop, I discovered that the front bumper of the black Citroen car had collided into the left side fender of my car.

Both vehicle then drove further ahead to the next U-Turn point and we stopped at the lane before the turning. The driver for the black Citroen car, is a Chinese man, in his fifties to sixties and spoke in a strong Mandarin accent. When I asked the first time whether the driver wanted to settle the matter privately, he placed the blame on me instead and asked to lodge a Police report. The second time I asked for his particulars, he then mentioned to lodge a Police report again. The driver then got back into his car and

then drove off.

My wife then assisted to call for Police. Ambulance also came to check on my wife whom mentioned that she was experiencing slight trauma. The paramedics checked on her and later asked if she wished to be conveyed. Thereafter, we signed the non conveyance form. There were no visible injuries on my family.

My car suffered scratches and dents on the left side fender. My front bumper also got slightly dislodged. The black Citroen suffered damages to the front bumper.

I did not have any in car camera installed in my car. The Traffic Police officer then advised me to lodge a Police Report with regards to this accident as a Hit and Run under TP Investigation Officer: Feroz (Tel: 6547 6206).
