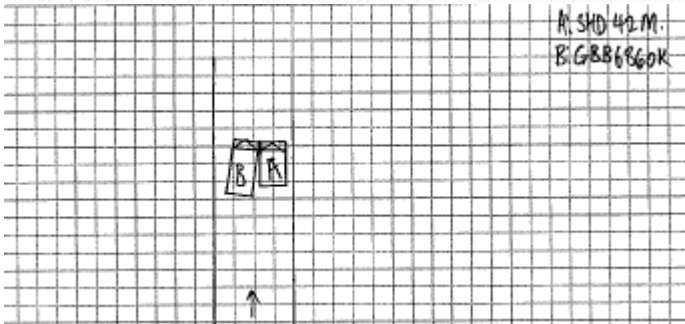
Dear Vic
