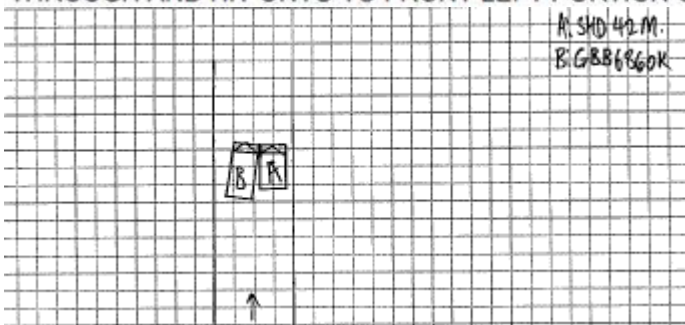
Dear Vic
