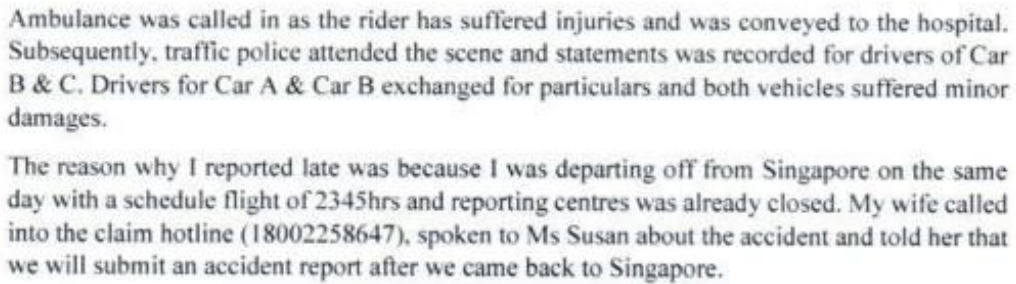

Car A and Car B (behind Car A) was traveling on the 2nd lane towards Alexandra Road/Queensway Junction when Car A was changing lane to the left, stopped abruptly halfway between 2 lanes (see photo below of the position of Car A).



Car B slowed down and came to a stop before the yellow box, due to front vehicles stopped because of red traffic light (based on FRONT video footage). Motorcycle which was traveling within his own lane from behind (third lane), had left signal light on, self-skidded and hit onto car B and Car C (based on REAR video footage), which was already stationary.

Brief Details.

On 31/01/2019 @ about 1905hrs, I was travelling along Alexandra Rd towards Ganges Ave just before Queensway Shopping Centre when a black Toyota Alphard (SLP 3646R) in front of me, was in the midst of changing lane to his left, suddenly stopped. I managed to stop in time and seconds later, I heard a loud noise and a jerk. I came out of my car and realised that there was a motorcyclist lying on the road and bike was leaning on it right side.

A white Nissan Qashqai (SKW 4042B) which was on the right of my car was also involved in the accident. According to said white Nissan's car cam recording, the motorcyclist was riding within his own lane behind white Nissan (Same as white Nissan) and self-skidded, leaving a trail of tyre skid mark. It then hit onto my rear of my vehicle and then hit onto the white Nissan. The rider was trying to squeeze in between my car and the white Nissan after the white Nissan slowed down his vehicle due to heavy traffic. Motorcyclist was conveyed to hospital. No injuries on me and my 2 passengers. Damage to my car: scratches on rear bumper.

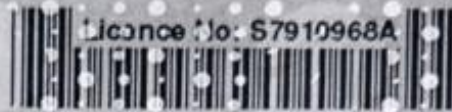
