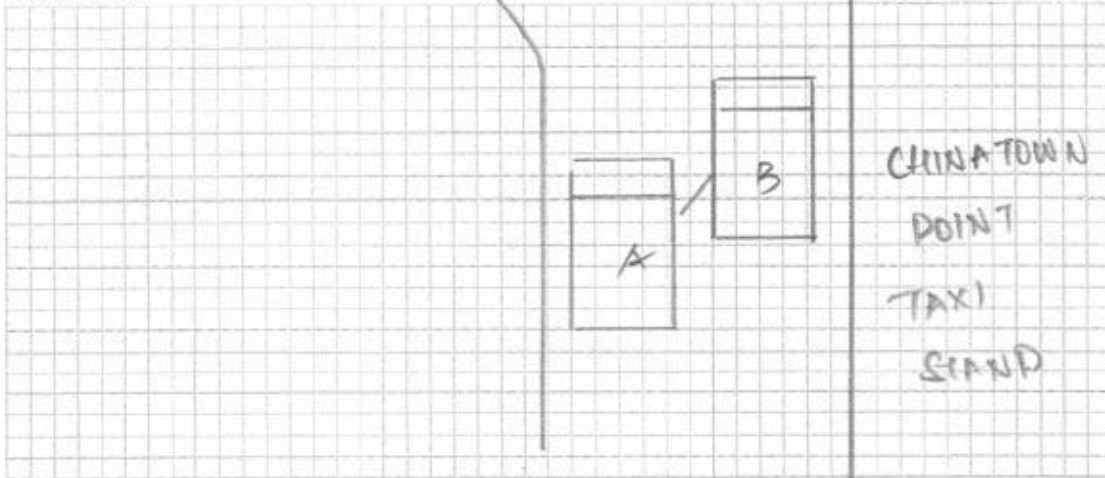


SKETCH PLAN

* OPENING DOORS OF VEHICLE *

ON 05/02/2019 @ 0110HRS, I WAS DRIVING MY TAXI (SHB 8005 D)
TRAVELLING ALONG CHINATOWN POINT TAXI STAND DRIVEWAY.

WHILE I WAS MOVING AHEAD, SUDDENLY A PASSENGER FROM VEHICLE
B (SHC 8717 C – COMFORT TAXI) WHICH WAS INITIALLY STATIONARY ON

AS SUCH, IT HIT AGAINST THE RIGHT PORTION OF MY TAXI.

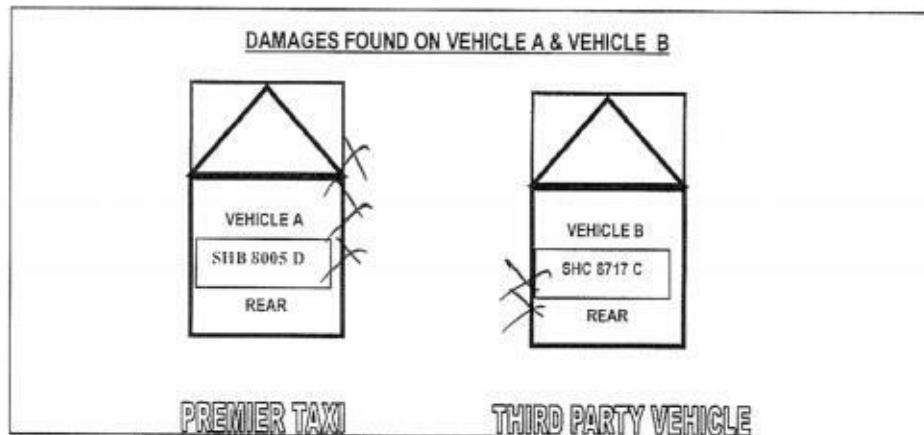
DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE RIGHT PORTION
