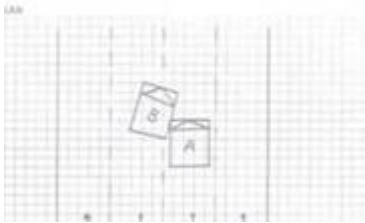
We refer to the above matter and your e-mail below.

The accident video footage does not show our Insured changing lane.

We append below our Insured statement:

On 06/02/2019, at about 2200hrs, I was driving my vehicle bearing plate no. SLJ7886U (Red Mazda 3) together with my wife. We were heading back to Singapore from Johor Bahru. I was from the flyover at Johor Bahru (Jalan Lingkaran Dalam, opp SHELL petrol kiosk) on the most left lane. There would be a point whereby my lane would merge together with the road from below. The traffic at that point of time was massively heavy and slow moving. I then noticed a Honda civic car (light blue) bearing plate no. SLV6235S, from the left side trying to squeeze his way into my lane. My wife told me to allow him into the

as the car was almost head on head. I decided to stop the car as his car was very near to the car in front of me. I decided to allow the blue car to enter my lane. He continued to squeeze his way into my lane. At one moment, I saw a lady from the blue car (right rear passenger), sticking her head out of the window and was trying to inform me that the car had already touched each other. The driver did not stop and continued to drive forward. The blue car then entered my lane, stop in front of my vehicle and the driver came out of his car. I then got out of the car to make a check as well. I realized that the other car had my car's paint mark stain on his right front and rear door and the right rear mud guard as he told me to make a report. We did not exchange for particulars but instead just took photographs of the other cars and went back into the car. We then carried on with our journey back home to Singapore.

Based on BOLA Scenario 15, vehicles that are changing lane should only change when it is safe. At that point of accident, there is a heavy traffic jam, your insured should not change lane without exercising caution and caused accident to occurred.

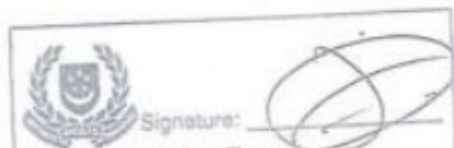
