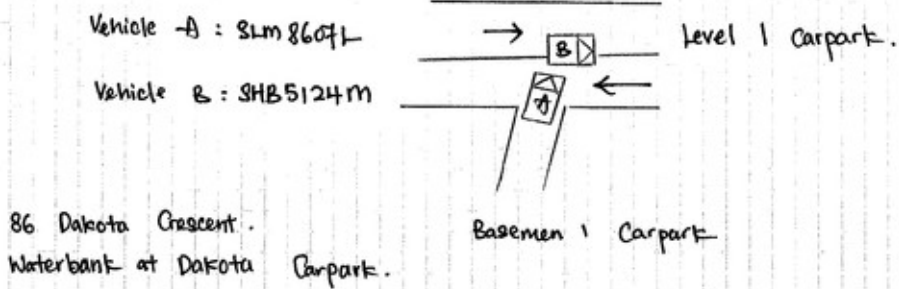

SKETCH PLAN





DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

 Vehicle B rear side portion.

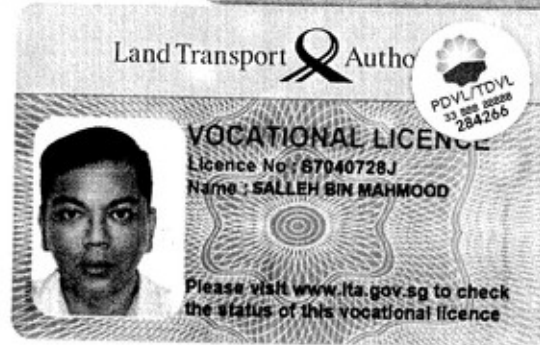
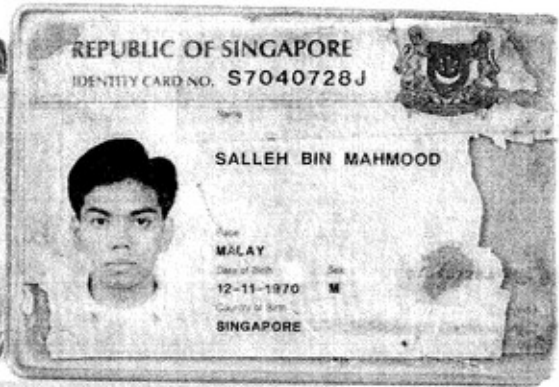
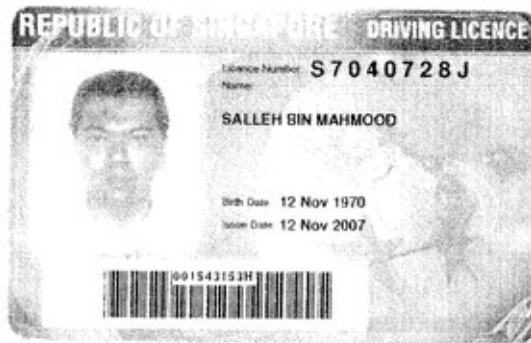
