Circumstances of Accident

ON MONDAY ,4/2/2019 @8.30AM , I WAS DRIVING A TOYOTA HARRIER BEARING REGISTRATION NUMBER SV31U ALONG LAVENDER STREET HEADING TOWARDS JALAN BESAR ON LANE 2 . THE WEATHER WAS CLEAR AND THE TRAFFIC WAS HEAVY . ALL THE VEHICLE ON LANE 2 AND 3 WERE STATIONARY WHILE THE VEHICLE ON LANE 1 WERE MOVING SUDDENLY A VOLSWAGEN GOLF BEARING REGISTRATION NUMBER SLU2711R ON LANE 3 CUT INTO LANE 2 AND HIT MY CAR RIGHT REAR AND SUBSEQUENTLY COLLIDED WITH ANOTHER VEHICLE SDS3338J BMW 528GT ON LANE 1.I ALIGHTED FROM MY CAR AND NOTICED MY RIGHT REAR BUMPER WAS DAMAGED AND ITS ALIGNMENT OUT. IMMEDIATELY, I TOOK A PHOTO OF MY CAR AND WE EXCHANGED DRIVER'S PARTICULARS. SINCE MY CAR HAS NO MAJOR DAMAGE, I DROVE OFF TO AVOID A CONGESTION PRIOR TO POLICE ARRIVAL. Describe Circumstances of the Accident

On Monday, 4/21/14 @ 8:30am, I was driving a Toyota
 Harrier bearing registration number SV314 along Lavender Street
 heading towards Jalan Besar on Lane 2. The weather was
 clear and the traffic was heavy. All the vehicles on Lane 2
 and 3 were stationary while the vehicles on Lane 1 were
 moving. Suddenly, a Volkswagen Golf bearing registration
 number SLH 2711 R on Lane 3 cut into Lane 2 and hit my
 car's right rear and subsequently collided with another vehicle
 SPS 3338 J a BMW 528 GT on Lane 1.
 I aligned from my car and noticed my right rear bumper
 was damaged and its alignment out. Immediately I took a
 photo of ^{my} car and we exchanged driver particulars. Since
 my car has no major damage, I drove off to avoid a
 congestion prior to police arrival.
 This is my report to file claim against SLH 2711 R.

Accident Sketch Plan

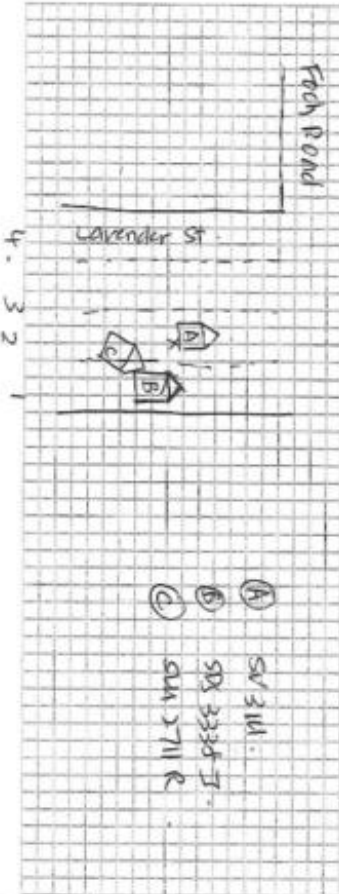

Sketch Plan



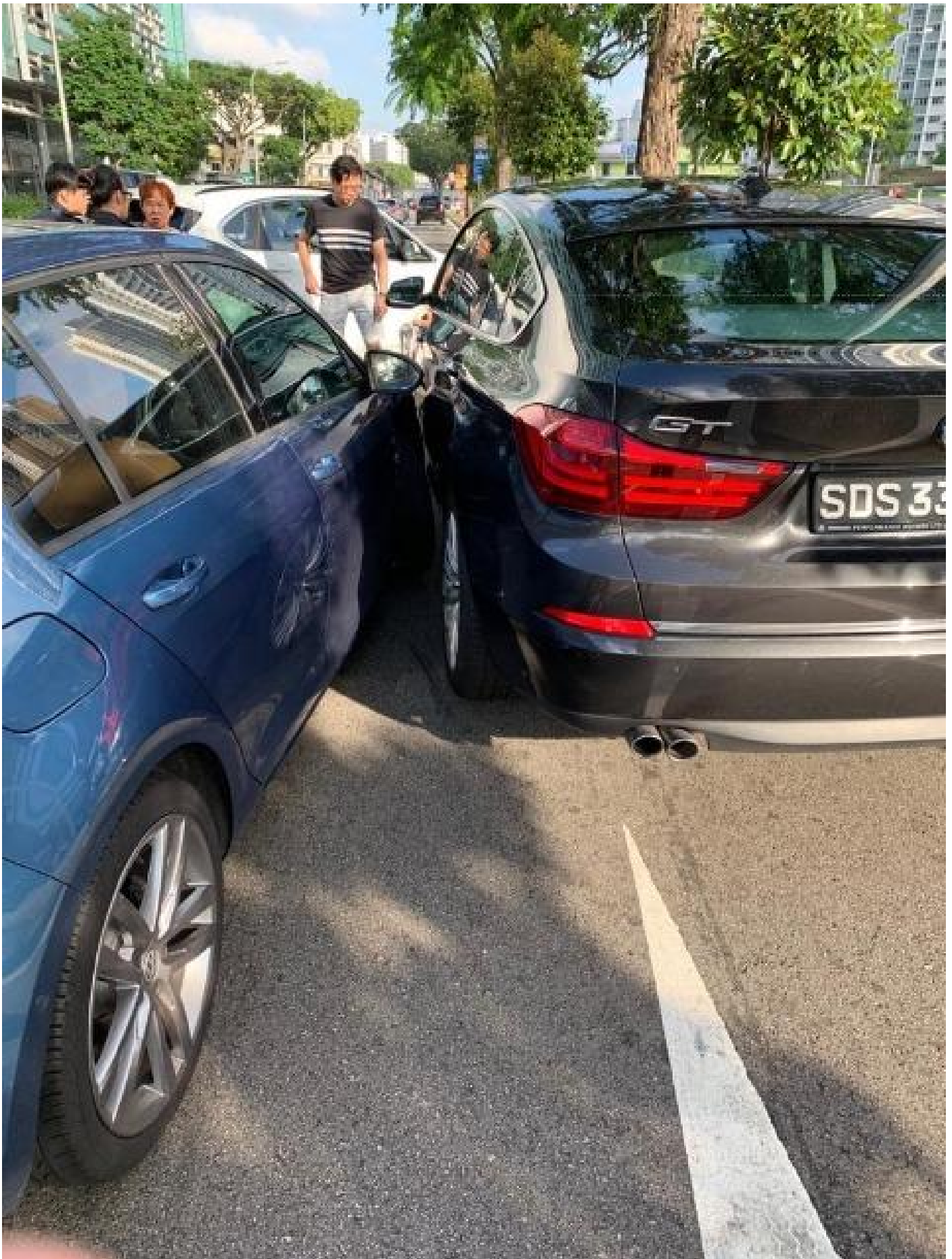

Brief Details.

On the above mentioned date and time, I was driving my vehicle SOS3336J along Lavender Street heading towards Jalan Besar. The traffic was heavy at the point of time and I was driving along lane 1. All the vehicles on lane 2 and 3 were stationary while the vehicles on lane 1 were moving. Suddenly, one vehicle SLU2711R cut into the front of my vehicle, into my lane and collided onto my vehicle's front left bumper in the process. The driver of SLU2711R had also collided onto another vehicle's (SV31U) right rear bumper which was along lane 2, in front of SLU2711R at the point of time.

I alighted from my vehicle and noted that my left front signal light, bumper and left passenger door were damaged. After taking some photographs of the accident scene and exchanging contact details, the driver of SV31U left prior to police arrival as her vehicle was still able to move. The driver of SLU2711R also claimed that he wanted to merge onto my lane, lane 1, and had turned on his right signal before merging. I did not notice his vehicle signal however when I saw his vehicle suddenly merging into my lane, I quickly stepped on my brakes, sounded my horn to warn him and tried swerving my vehicle towards the right to avoid the collision.

Police came to scene and towing crew was activated to tow SLU2711R as his vehicle was unable to move. I am lodging the report as advised by the police officer at scene. I have a witness for the accident and his details are as listed below. The witness had approached me after the accident and informed that he saw the entire incident from the back of my vehicle.
