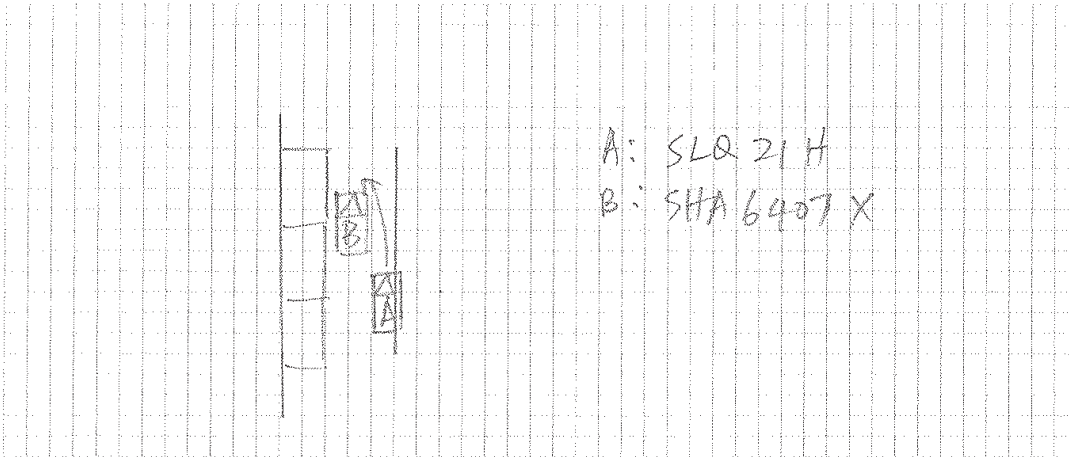

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

① I was driving along Joo Chiat Place at the time of the incident and was driving at a relatively slow speed. As the taxi vehicle SHA 6407 X was parked in a stationary position with the hazard lights on I had to make a slight right shift to the oncoming lane so as to avoid the taxi as it was not parked in a parking lot. As there was an oncoming car moving at quite a fast speed I got a shocked and swerved back to the left lane, thus hitting the side mirror of the stationary taxi. My car was only slightly scratch (side mirror) and no one was hurt. The taxi ~~rear~~ side mirror dropped off the taxi (could not be found though) and as I was rushing off I gave the driver my particulars and was willing to compensate the damage.
