Dear So Chow

I have reviewed the matter.

Replacement of chassis is not allowed under the Road Traffic Act (Motor Vehicles, Construction and Use) Rules. Please refer to attached.

LTA also does not allow the replacement of vehicle's chassis This can be found under LTA's modification guidelines.

The chassis of a vehicle is an integral part of a motor vehicle. Even if Eurosports agree to repair the chassis instead of replacing the chassis, the structural integrity of the vehicle may be compromised as repairing would involve heating, knocking and straightening etc of the chassis. The material strength of the chassis may be affected by these type of repair work, which will weaken the chassis resulting in possible safety issue to the vehicle.

Legally, replacing the chassis is not allowed while on the other hand repairing the chassis may pose safety issue to the vehicle.
