Brief Details.

On 23/01/2019 at about 1700hrs, I was riding my motorcycle, a Black Yamaha RXZ, (vehicle no. FD8068K) along Upper Thomson Road (heading towards Sembawang). I was approaching the X-Junction of Upp Thomson Road & Marymount Road, travelling on lane 2, turning right on to Marymount Road.

At the junction, I made a check for oncoming traffic and saw an oncoming car that was still far away. As such I made a right-turn.

Subsequently I felt an impact and I fell off my motorcycle. I realized that I was in an accident involving me and another car.

Afterwards, a Chinese man and Chinese lady, whom I believe one of them to be the driver, approached me. A few minutes later, an ambulance attended to me and I was conveyed to Tan Tock Seng Hospital. After the accident I was in a daze and could not recall much of the incident.

Due to the accident, I sustained injuries on the left side of my body, and a hairline crack under my left-eye. I was hospitalized from 23/01/2019 and discharged on 25/01/2019. I received 14 days of Hospitalization leave from 23/01/2019 to 05/02/2019.

I am unsure what are the damages to my motorcycle.

I would like to state that there is a camera on Lamp Post 27 along Upp Thomson Road. I am lodging this report for police assistance.
