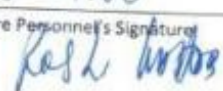

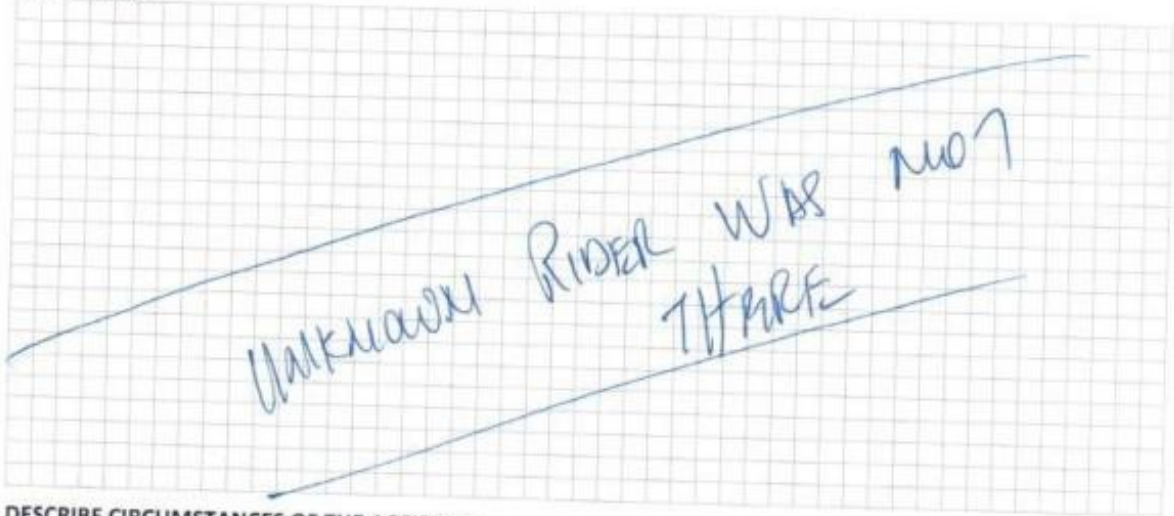

Brief Details.

On 14/02/2019 at around 0640hrs, I had parked my Vespa (FBK7817H) beside one of the pillars at Anchorpoint Shopping Centre loading and unloading bay and proceeded for my Part time work. At this point in time, there were no damages on the front of the bike.

At around 0650hrs, I then came back to my bike and rode back to my place of residence. When I had arrived at my residency, I realized that the right front side of the bike had a dent, scratches as well as a broken signal light. I then called Anchorpoint Shopping Centre Security and they informed that there was CCTV coverage of the area. When asked if I could view, they informed that the security officer in charge of the CCTV was on course and will only be back on the 17/02/2019.

I am unaware of the cost of getting a replacement, I am certain that the damage was done at the said location as when I had parked my bike, the bike head was facing me and I did not find any abnormalities.
