



Lorry reserve onto my taxi





Brief Details.

On 12/02/2019 at about 1755hrs, I stopped my taxi bearing the registration number SHD5404U at Blk 958 Hougang Street 91, at the central rubbish chute as a passenger had requested to stop there to alight. At the location where I stopped my vehicle, there was another vehicle, a lorry bearing the registration number GX6196U had parked in front of my vehicle. There is no sign that the vehicle is moving off during that point of time. After stopping, I then turned over to collect the payment of the taxi fare from my passenger. At this point, I heard and felt an impact. I then noticed that the lorry in front of my vehicle had reversed into the front of my taxi. I then alighted from my vehicle and contacted the driver of the lorry. He addressed himself as Edwin Soh, HP: 88215921. When I had requested for his driving license, he informed that he do not have to produce it. As such, I believed that he do not have a valid driving license to drive the vehicle. I do not have any in car camera installed. Due to the impact, there are scratches and dents at the front part of my vehicle.
