REFER TO POLICE REPORT NO:T/20180709/2131 LODGED AT ORCHARD N.P.C. ON 09/07/2018 BETWEEN 1515HRS TO 1520HRS, I DROVE MY CAR SLZ331R(PEUGEOT/GOLD COLOUR) TOGETHER WITH MY DAUGHTER ARRIVED AT TANGLIN SHOPPING CENTRE. UPON ARRIVAL, I PARKED MY CAR AT THE LEVEL 1 LOADING BAY CARPARK. AFTER I SECURED MY CAR, I FELT AND WENT INTO TANGLIN SHOPPING CENTRE. WHEN I RETURNED BACK TO MY CAR AT ABOUT 1527HRS, I WAS APPROACHED BY A MAKE CHINESE SUBJECT WHO PASSED ME A PIECE OF PAPER AND AT THE SAME TIME, HE SAID THAT HE WITNESSED A VAN HAD COLLIDED WITH MY PARKED CAR WHILE REVERSING. I IMMEDIATELY MADE A CHECKED AND CONFIRMED THAT THERE ARE SCRATCH MARKS AND SOME PAINT HAD CHIPPED OFF AT THE FRONT LEFT SIDE. TO BE CONTINUED..... ADDITIONAL INFO: I have gone back to Tanglin Shopping centre to interview the witness Steven (82883781 mobile) who is the cleaning supervisor of the building (for past 12 years). He works for IPM Cleaning service He says he saw: The driver is 50+, dark skin, there were no passengers in the vehicle. I also managed to get the person in charge of the security cameras Mr Loh to look through the CCTV from 3.23-3.27pm where I was not at the car, He found the vehicle to be a black MPV with license plate no. SJN 133H I hope this will help with the investigation. My family and I will be in KL this coming weekend till Wednesday. If you need to contact me I am available still via email and my mobile But just in case, my husband's contact is Alex 96188381, you can also contact me via him. Our vehicle is registered under his name.

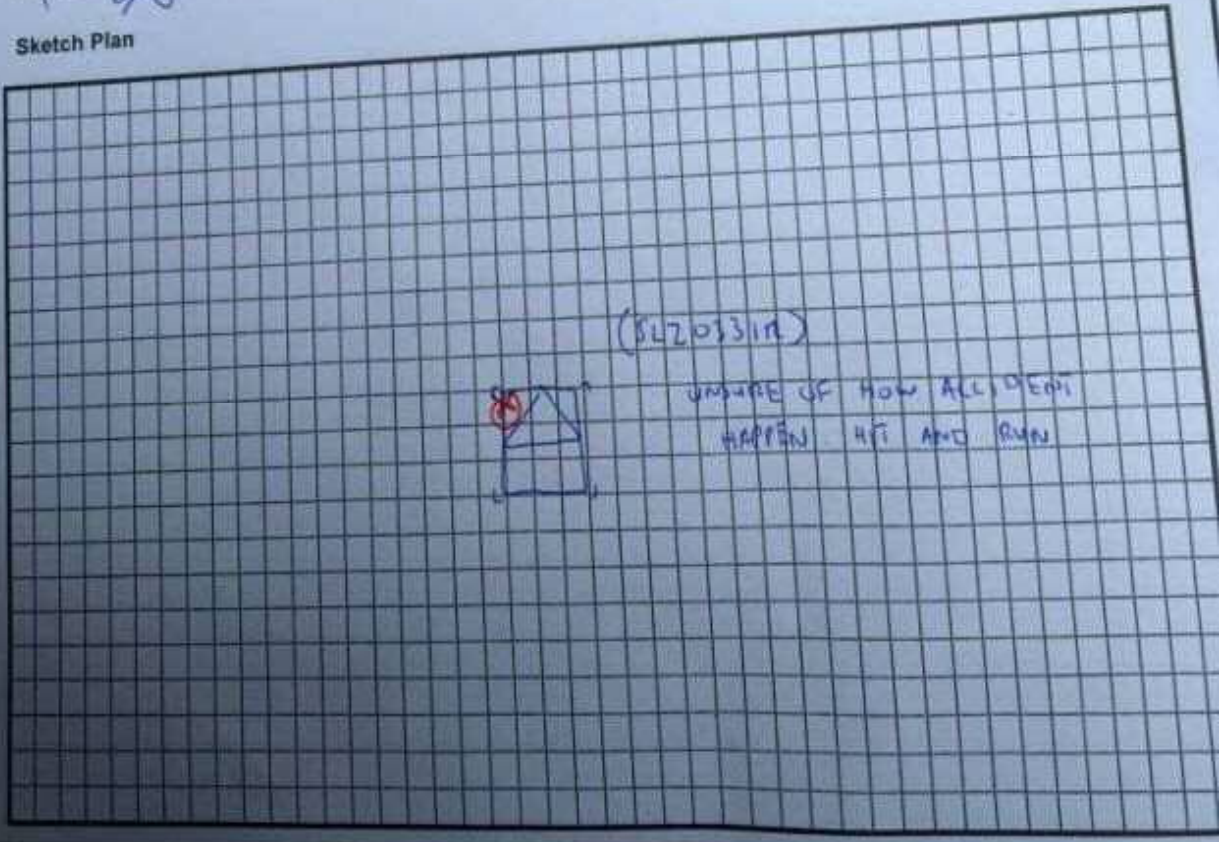

Brief Details.

On 09/07/2018, between 1515hrs to 1520hrs, I drove my car SLZ331R (Peugeot/Gold colour) together with my daughter arrived at Tanglin Shopping Centre. Upon arrival, I parked my car at the level 1, loading bay carpark. After I secured my car, I left and went into Tanglin Shopping Centre

When I returned back to my car at about 1527hrs, I was approached by a male Chinese subject who passed me a piece of paper and at the same time, he said that he witnessed a van had collided with my parked car while reversing. I immediately made a checked and confirmed that there are scratch marks and some paint had chipped off at the front left side.

However, the letter only written plate number as '133-H'. The eye-witness who only gave his name of Mr Steven, informed that after the collision, the van moved off fast, as such, he only managed to write the numbers, and the suffix letter of the van. He pointed to a black Mercedes van nearby and said that the van which collided with my car is very similar, after which I then took photo of the Mercedes van from my handphone.

Mr Steven then told me that there is security office there, but asked to returned back tomorrow to seek assistance. I then contacted Wilson carpark to check on the CCTV camera there, but a staff advised me to lodged a police report and that they will only pass any footage to the police. I acknowledged. I have an in-car camera installed facing both front and back, however, I have yet to view it.
