The video footage showed that our taxi was stationary waiting for the front vehicles to move off when your insured's vehicle sped past and caused the accident.

1<sup>st</sup> cctv showed the left front wheel of your insured's vehicle was seen tilted towards the right and touching the white dotted line (as per screen shot attached).

2<sup>nd</sup> cctv showed the rear footage.

3<sup>rd</sup> cctv showed your insured stopped some distance away.


Dear Lee Gek,

We refer to the above matter.

Please be informed that Liability unclear on this matter. There is no conclusive evidence yet to substantiate either party's version. Below is a copy of our insured's accident report statement for your perusal.

**Describe Circumstances of the Accident**

On 11/2/19 about 10:25pm, I was driving along Ang Mo Kio Ave 3 near junction Serangoon North Ave 3. On right hand side of traffic and I maintain normal speed as lights turned green I drove ahead, the left lane to my car was a queue of cars. I heard a knocking sound and realised a taxi driver side mirror onto my passenger side mirror. Both our side mirrors were damaged. I pulled over to side of road (Ang Ave 3) and waited for the taxi driver. I took photo of his side mirror after confirming no other damage. I gave him my particulars. No injury suffered by both parties passenger & my son. The taxi (SMRT) was not carrying any passengers.



We are in a course of investigating into the circumstances of the accident.

In order to justify your client's claim smoothly and promptly, we appreciate if you could kindly furnish us a copy of CCTV footage / accident scene photos / evidence for our necessary action.

Your prompt reply will be very much appreciated.
