After which I was conveyed by ambulance to Tan Tock Seng Hospital and I was given 5-day MC and I suffered abrasion on my left finger, elbow, knee, pain of the left chest and the heel area and also pain at my spine area

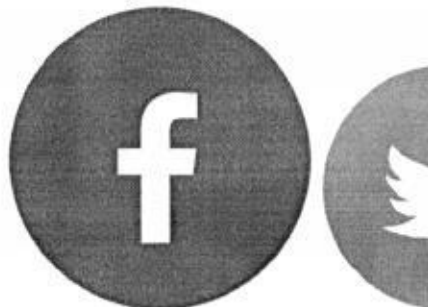

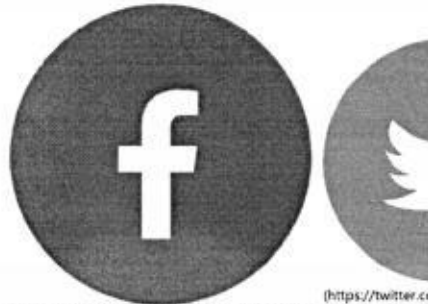
