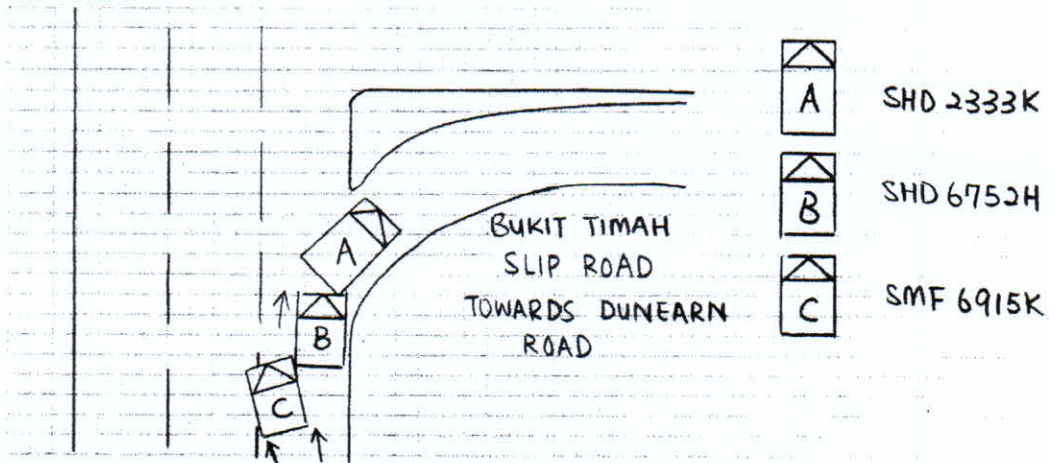

On 15.02.2019 @ 0810 hrs, my taxi SHD2333K stopped along Bukit Timah Road slip road towards Dunearn Road keeping safe distance with front vehicle. While stationary, one Comfort taxi SHD6752H rear ended my taxi. Due to the great collision impact, my taxi surged forward to the front. However my taxi did not have any contact with the front vehicle.

After the accident, we alighted from our vehicles to check on the damages. I noticed it was a chain collision involving another vehicle SMF6915K being the last vehicle. Co-incidentally there was a police patrol car drove behind SMF6915K and the policemen immediately alighted to control the traffic and passed me ^a card to lodge police report. After the accident, I felt backache, neck and lower hip pain so I will consult doctor if pain persisted. My in-car front and rear camera captured the occurrence of the accident.
