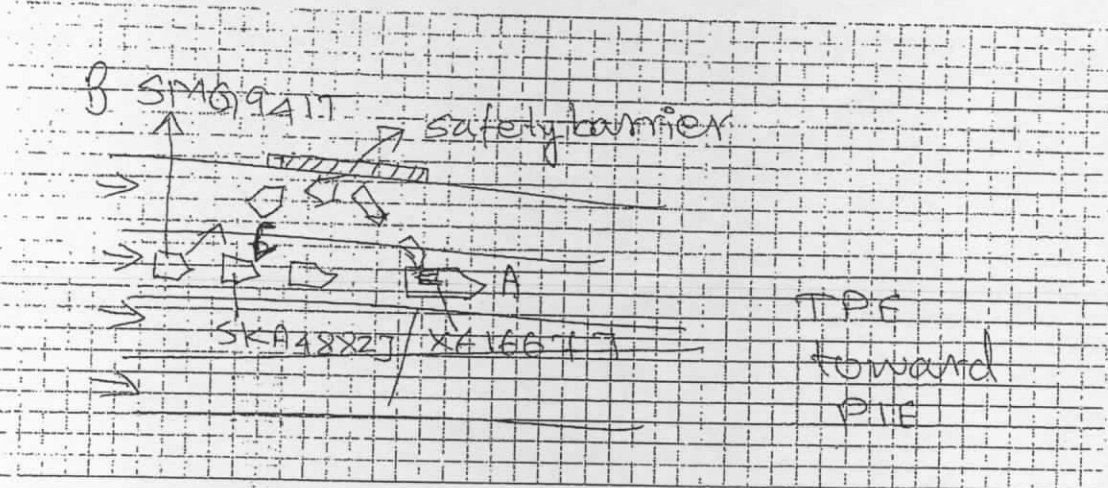

CONTINUATION OF REPORT

Brief Details.

1. On 6 February 2019 at about 12.00pm, I was driving my company vehicle(lorry) registration No: XE1667J along Tampines Expressway towards PIE. This is four lane road I was driving on the second lane from the left. I was driving the vehicle with another worker(Thai Nationality/33 years old) seated with me and two other workers (Two Bangladeshi) seated at the rear of the lorry I was driving in.
2. As I was driving I suddenly noticed from the right side mirror of my vehicle a black car registration No: SMG941T, the driver a male/Chinese/ about 50 years old, driving very fast from the centre lane from the rear side and suddenly I heard a loud sound and this vehicle had collided onto the left side of my vehicle. I jammed brake. Both myself and my three workers did not sustained any injuries.
3. Upon alighting to make a check I noticed another vehicle driver (a male/Chinese/30 + years old) of vehicle registration number: SKA4882J had halt on the left extreme lane and I believed the vehicle driver of vehicle registration number: SMG941T while driving in a fast manner had collided onto the rear of vehicle registration No: SKA4228J and then banged against the cement barrier on the left side of the road and the driver could have lost control and collided onto my vehicle.
4. There was another vehicle a Police car (registration No) I unable to recall was on the left extreme lane but I did not notice any damage to the Police car. Only the driver and his passenger (a male/Chinese) boy of vehicle registration No: SMG941T, was conveyed to hospital. The Police attended reference No: F/20190206/0041, In/charge case: Hidayu/65476403. My company vehicle had slight damage.
