While driving along Telok Blangah Heights towards Henderson Road, not long after exiting from multi-storey carpark (Blk 88A, Telok Blangah Heights), emergency brake was applied by SKU7762Y upon seeing no sign of slowing down nor give way by SLG7185A near the Parallel Broken White Lines in SLG7185A travel direction. However, due to the fast speed of SLG7185A at the parallel broken white lines, it resulted in a collision between the side of SLG7185A with the front of SKU7762Y. 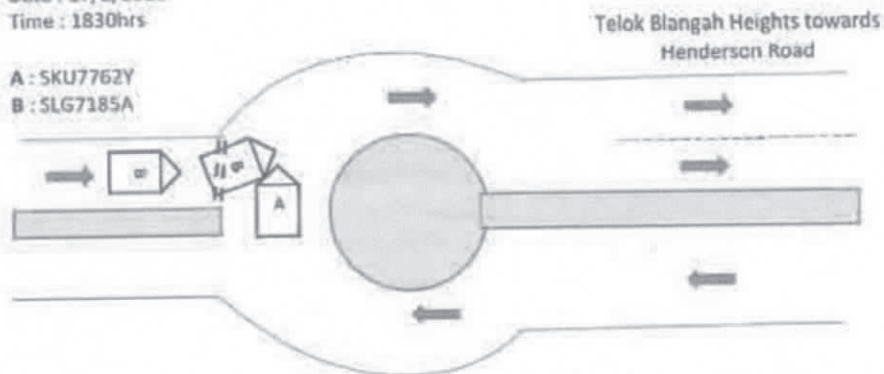


Accident Sketch Plan
