I, Ng Ming Han Eugene of SMF7563K was travelling on Hillview Avenue on the right most lane of a 2 lane carriage way towards Bukit Batok Avenue 2 together with my Wife (Pang Su Yi S8710178i) and Daughter Ng Zhi Lin Emilla (T1818622A), upon coming up to the exit of meralodge condominium. I noticed the other incident car SMH6211Y exiting the condominium.

The other driver failed to notice my presence and failed to turn out onto the left most lane of Hillview Avenue. When I saw that his car was encroaching onto the right lane of Hillview Avenue Lapplied my brakes fully and sounded my hom simultaneously. As there was not enough stopping distance for me to stop and a divider on my right, our cars collided.

As there was an infant travelling in my car and my Wife complaining knee pain, I called for an ambulance for assistance.

The paramedics checked Emilia and certify that she was okay but advised for us to do a further check at a hospital.

The paramedics also attended to Suyl and advise for her to be conveyed to NUH for further checks. As our baby Paediatrician is located at Mount ELIZABETH Novena, we decline the offer from the Paramedics and my parent in laws conveyed Suyl and Emilia to Mount Elizabeth Novena for further checks.

Shortly after the incident, a Traffic Police Officer arrived on the scene to take the statements and particulars of the Drivers of both cars.
