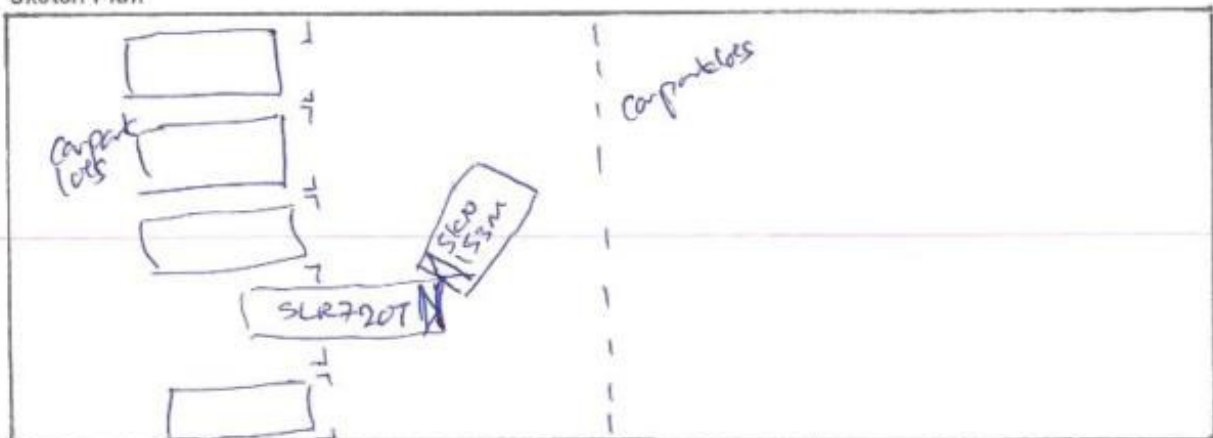

Describe Circumstances of the Accident

I was reversing into a carpark lot at Glanmole Hunter Centre on Sunday 17 February 2019 at 11:40 hrs. As there were many vehicles waiting for available lots, as well as vehicles leaving the carpark. Horns were being sounded regularly. The vehicle vacating the lot I was reversing into was a truck. After it cleared, I continued reversing. As I was almost in the lot, I felt an impact. I initially thought that I had accidentally hit the vehicle in the lot next to me, but realised that this was not the case upon checking my left wing mirror. That was when I discovered that another vehicle - Skoda - had driven into the front left of my car. After I got out of the car, several accusations about fault were traded. I requested for contact and other details of the driver of the vehicle that hit mine, and after an exchange was done she drove off.
