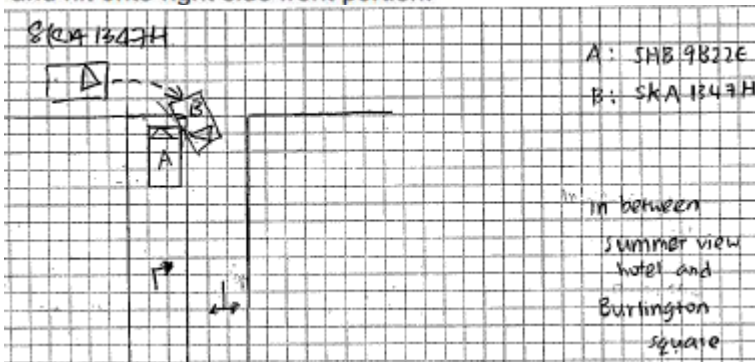
Dear Vic

However we enclosed driver statement report for your investigation. Our taxi's was in stationary position due to checking for the oncoming vehicle in front of the stop line, your insured vehicle making right sharp turn and hit onto our taxi right side portion.

Circumstances of Accident

On 14.02.2019 at about 1015hours, I was stationary in-between Summer view Hotel and Burlington Square when I to check for oncoming vehicle. While stationary, suddenly vehicle B (SKA1347H) made a right sharp turn from Ben and hit onto right side front portion.
