

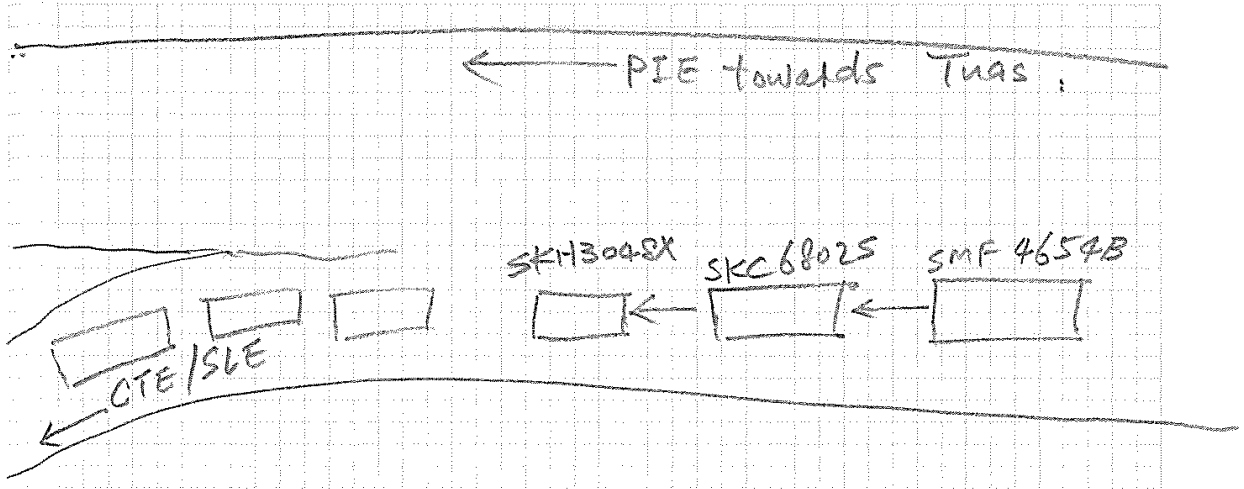

SKETCH PLAN



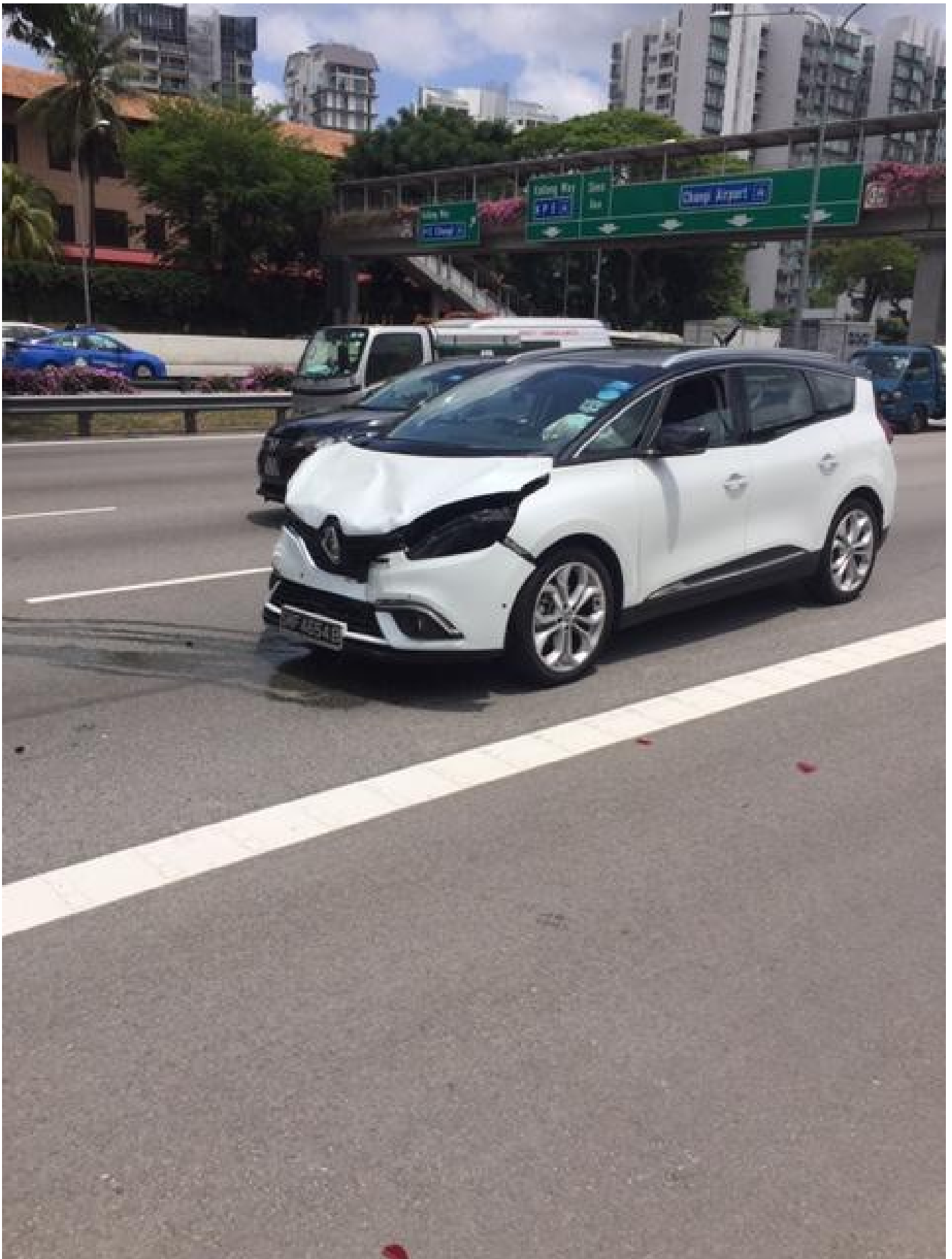
