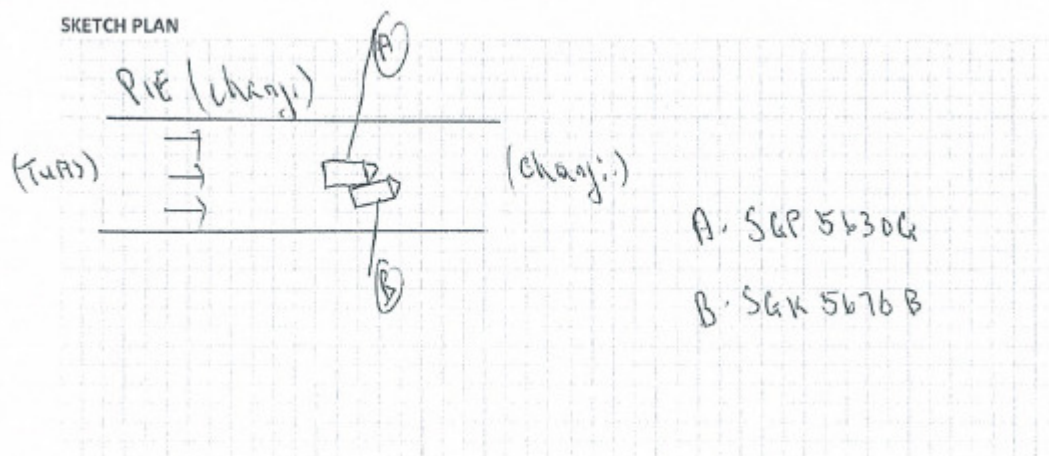

driving the vehicle at the time of accident.

Brief Details.

On 4/2/2019, I was driving my car bearing plate number SGP5630G along PIE towards Changi. I was on the second lane from the right. It was right before exit BKE and was at the bend area when I noticed a car bearing plate number SGK5676B lost control of her vehicle. She almost hit onto the divider but managed to swerve her car. However, she suddenly swerved left into the lane that I was driving on and emergency brake. Due to that, I collided onto the left rear side of her vehicle. No one was injured during the incident. However I felt unwell and went to the clinic and received 3 days of MC. I did not have any in-car vehicle camera.
