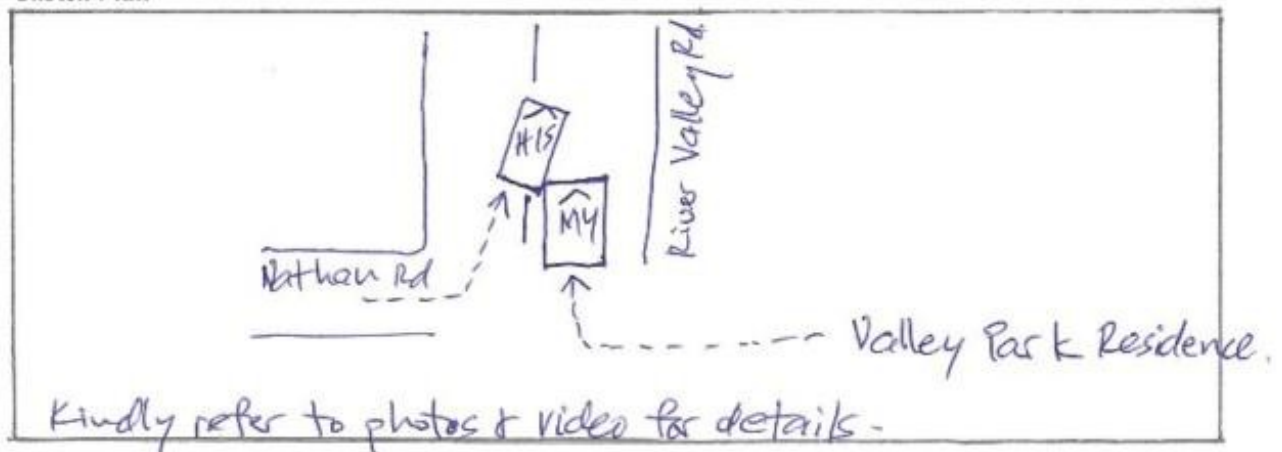

Sketch Plan




Common Statement

Describe Circumstances of the Accident


Weather - clear
Road - Dry
Traffic light - Working condition.
Traffic flow - light
Pedestrian flow - light at traffic light crossing.
I was waiting @ traffic light (Red) within Valley Park, for a right turn into River Valley Road.
As the light turned green, I drove ahead, slight right turn to wait for pedestrian to clear crossing.
At the same time, car STM32925 (his car) was waiting at Nathan Road traffic light to turn Left into River Valley Road.
As the pedestrian cleared the road, I drove forward into the right lane of River Valley road, keeping to the right edge of my lane (photo evidence), as I expected his car to maintain lane discipline keeping within his left lane since he is turning left.
Unfortunately, his car drifted into my lane, without signal or checking his blind spot. This caused both cars to side-swipe each other, evidenced by paint marks above his rear right tire area (body).
As he continued driving into my lane, while I kept to the right side of my lane, his rear bumper became embedded into my bumper (front left), shown by horizontal paint streak marks, as an extension of the side-swipe.
A direct collision of my bumper to his bumper will show a different type of damage and paint marks.

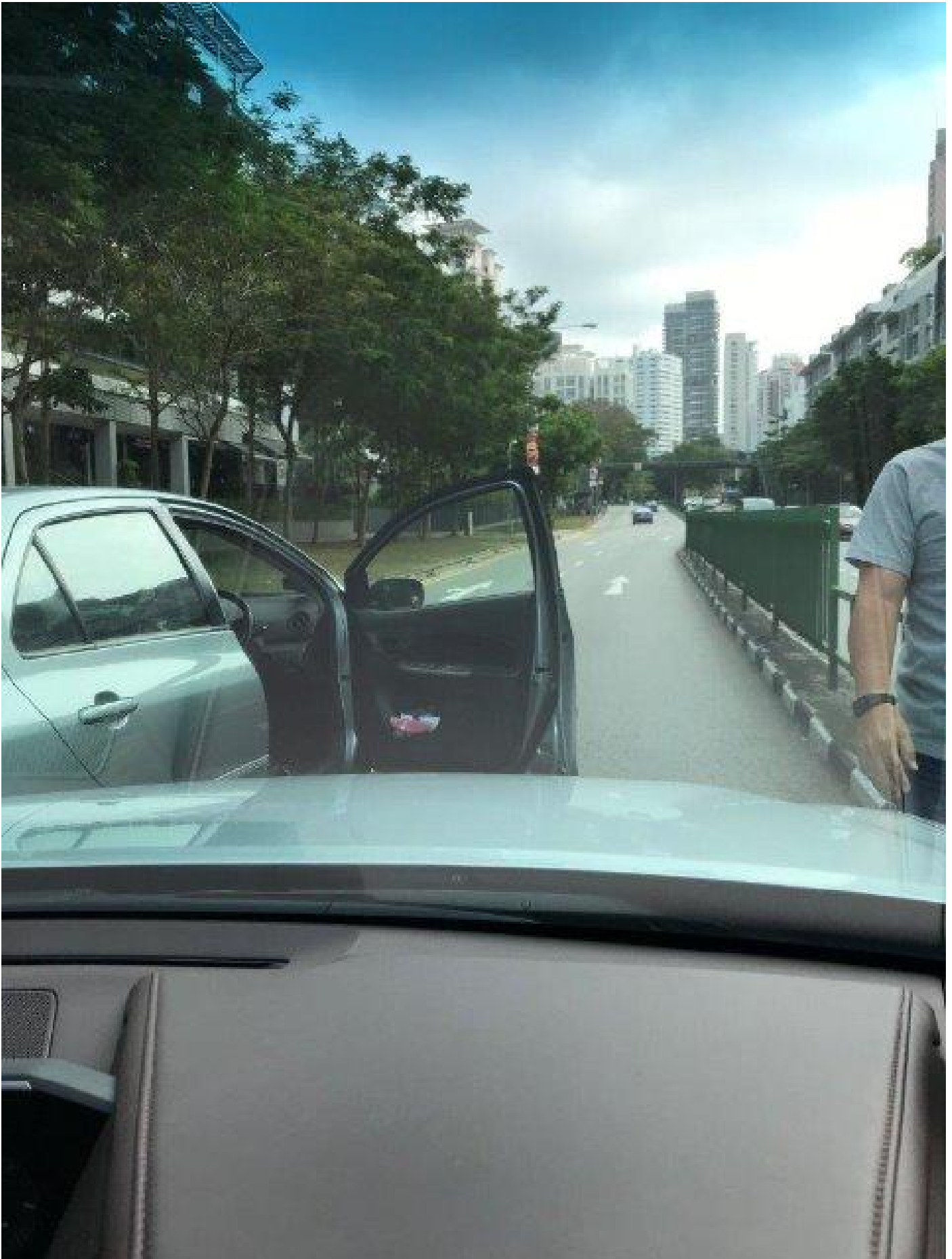

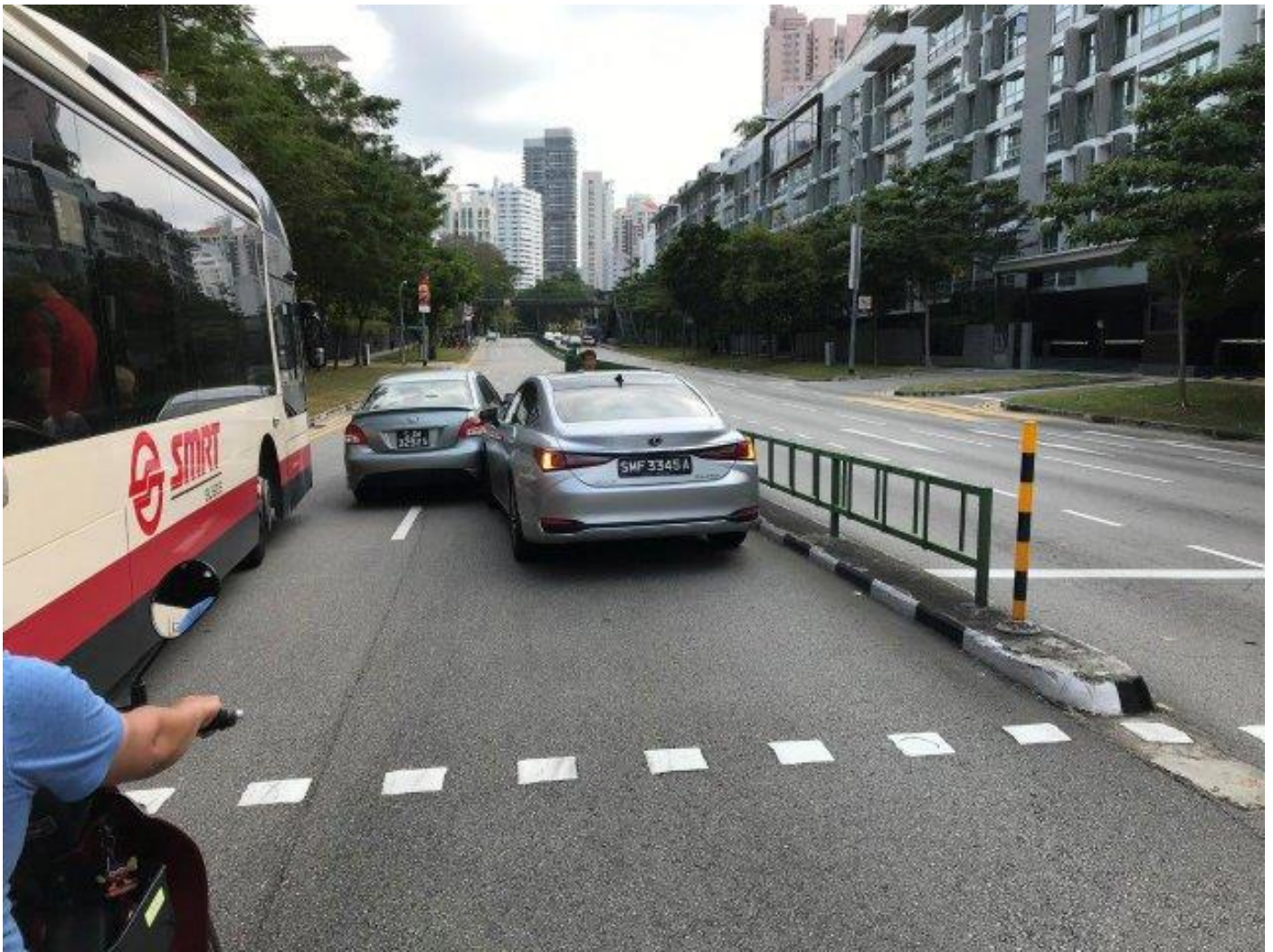
