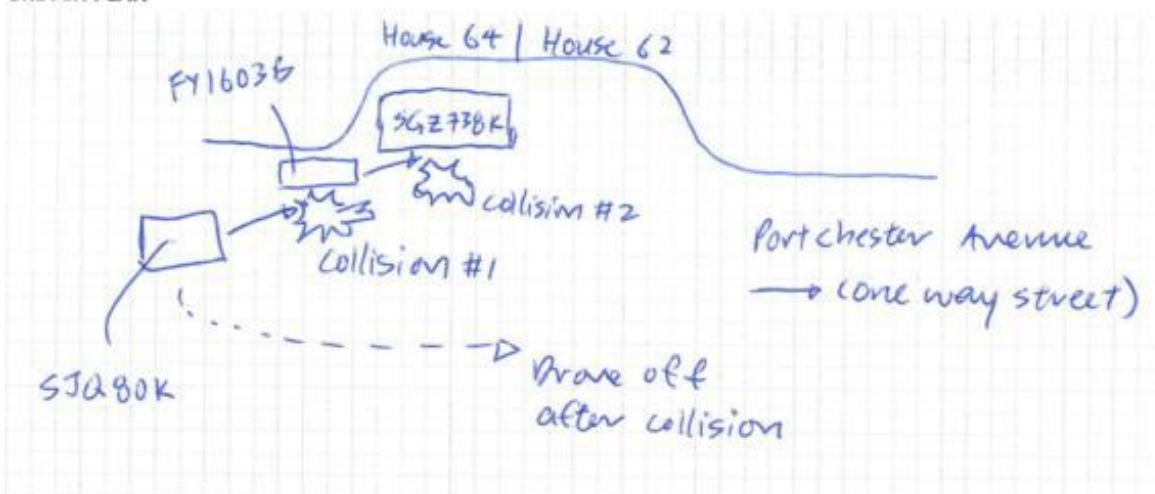

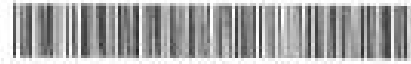

CONTINUATION OF REPORT

Brief Details.

I am writing to report a hit and run accident that happened at around 9pm on 5 Feb 2019.

I was visiting my mother-in-law at 64 Portchester Avenue and my car (SGZ738K) was parked in the lay-by in front of her house, in the direction of the one-way street. My cousin's motorcycle (FY1803B) was parked next to the right rear bumper of my car.

At the time of the accident, I was in house 64 Portchester Avenue. I heard a loud bang and came out of the house to investigate. Several neighbours also came out to investigate the cause of the loud bang. A guest at 68 Portchester Avenue informed me that he saw a blue Mini Cooper S, vehicle number SJC80K, stopping near houses 58 to 62 Portchester Avenue) before driving off.

We found several parts, including the mudguard of SJC80K, strewn along the street. Motorcycle FY1603B was knocked over. The collusion had dislodged its right exhaust pipe and flung it against the right rear wheel of SGZ738K - causing damages to the right side of the car.

I then called 999 and the operator dispatched two traffic police officers to investigate the matter. Together with the two traffic police officers, we later found vehicle SJC80K parked in the front porch of 67 Portchester Avenue. The front left mud-guard of the vehicle was missing.

We spoke to the owner of the house, Mr Chris Lee, who then confirmed that his daughter, Ms Lee Yern Ee (S9439786C) was driving SJC80K at the time of the accident and as Ms Lee had already left home at that time, he apologised on her behalf.

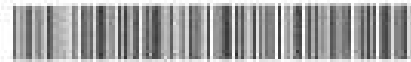
The responding officers recorded our statements under report number F/20190206/C197, which included videos of the incident taken from the front and rear in-car cameras of vehicle which was parked nearby. The videos were sent to Officer Raziz.

I informed Mr Lee that I will lodge a police report and inform my insurer about the incident and advised him to asked Ms Lee to do the same.
