Sketch Plan





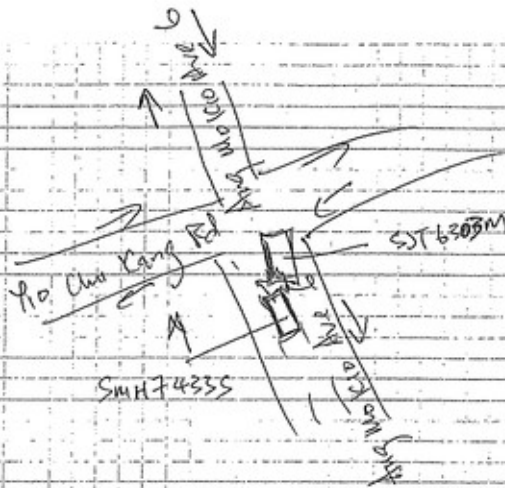
