On 10 February 2019 at about 9.23 pm, B1 (driver of SKK34P) was travelling along Maxwell Road towards Straits Boulevard on lane 1 of 3 lanes road and was stationary at the cross junction of Shenton Way due to red light signal. When traffic light turned to green for B1's direction, he had proceeded to make a right turn into Shenton Way when B1 collided into A1 (pedestrian - deceased) who was crossing along the signalised pedestrian crossing from B1's left to right on flashing green man signal.
