AT ABOUT 11 AM ON 21 FEB 2019. I WENT TO LEVEL 6 CARPARK OF CAPITAL TOWER TO COLLECT MY CAR. I DISCOVERED A NOTE ON THE WINDSCREEN SAYING SOMEONE CALLED "WENDY" HAS HIT MY CAR AND ASKED ME TO CALL HEP (HP: 97947941). I DISCOVERED THAT THE FRONT RIGHT BUMPER OF MY CAR WAS BADLY DAMAGED. THEN, I CALLED THE PERSON ON THE NOTE AND SHE CAME TO MEET ME AT THE CAR. SHE APOLOGISED AND OFFERED TO SETTLE THE CLAIM. HER HUSBAND ALSO CALLED HER AND TALKED TO ME, SUGGESTING THAT I SHOULD GO TO A SHOP HE RECOMMENDS. I DECLINED AS THE DAMAGE WAS EXTENSIVE AND I FEEL IT NEEDS A REPLACEMENT BY AUDI. I TOLD WENDY, I WILL LET HER KNOW THE REPAIR COST AFTER AUDI MAKES AN ASSESSMENT.

I told Wendy I will let her know the repair cost after Audi makes an assessment.
