ON 23/1/2019 AT AROUND 1100HRS, I PARKED MY VEHICLE NEAR 503 WEST COAST DRIVE OPEN CARPARK AND WHEN I GO COLLECT MY VEHICLE AND WAS ON MY WAY TO THE EXIT, SUDDENLY THERE IS ONE VEHICLE DROVE IN THE MIDDLE OF THE ROAD AND I TRIED TO KEEP TO LEFT TO ALLOW HIM TO PASS THROUGH BUT CAUSED ME ACCIDENTALLY STRETCHED ONTO VEHICLE B WHICH IS PARKED IN THE LOT.
