On 21/02/19 at around 4.00 p.m. I was driving in a black SAAB car license plate EH 3200T along Irrawaddy Road in the direction of the Thomson Road junction. As I was passing Courtyard Shopping Centre, a light beige Toyota VIOS license plate SKC 385T which was driving in front of me suddenly jammed on his brakes and came to a stop.
