SKETCH PLAN

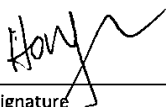

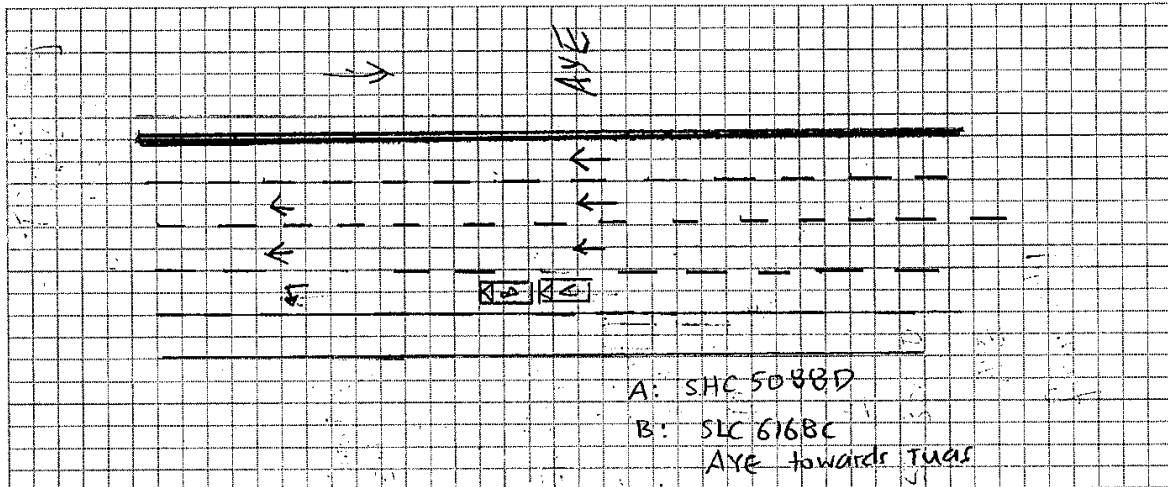
