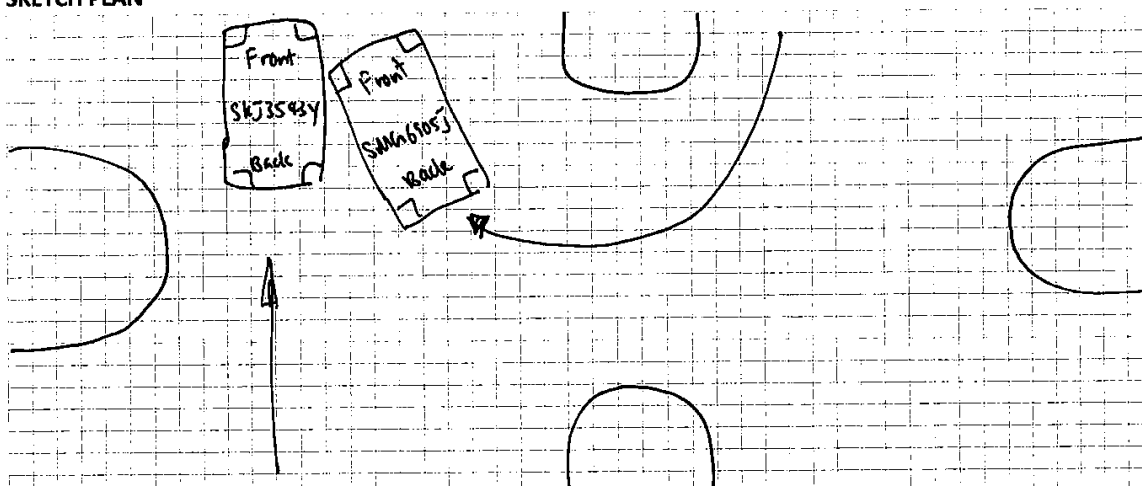

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Mr Peh (HP): 9751 9111

On 21 Feb 2019, at approx. 0650 am, at the junction of Sengkang West Way and Fernvale Road, SKJ3543Y was travelling down Sengkang West Way in the direction of Jin Kayu. This was in accordance to traffic greenlight.

Upon crossing the stopline and in the middle of the cross-junction, SMG 6905 J was observed to perform a U-turn into on-coming traffic.

Despite SKJ 3543Y performing E-brake, SMG 6905 J hit on driver's side and continued across front right portion causing damage to body and wheel.

Light was still observed to be green and green arrow for turning has not been activated yet.

Owner of SMG 6905 J, Mr Peh Tong Ho, verbally agreed to full compensation of damages to SKJ3543Y.
