

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On Feb 22, at about 6:00pm (18:00H), I was driving along Keppel Viaduct having come from AYE and heading towards MCE. Traffic was relatively clear; I was driving at about 80 km/h for about 3 minutes since CTE split with AYE. I was on the rightmost lane. Suddenly, the car in front of me (SLF126SP) seemed to brake. I did not notice whether her braking lights turned on, but I tried to brake as quickly as I could. I kept a distance sufficiently far for another car to cut in between my car and the other car. When the other car stopped, there were no hazard lights either. It is unknown why the other car stopped, especially since traffic was not heavy. After we exchanged contacts and drove off, the traffic was still not congested. Also, it was noted that after the collision, it was 2-3 minutes before the lady in the other car came out of the car. I did not ask why she stopped her car on the rightmost lane on the highway despite brake traffic, nor why she took such a long time to come out of the car. There is video evidence of the accident, ~~on~~ which video analysis may be performed.
