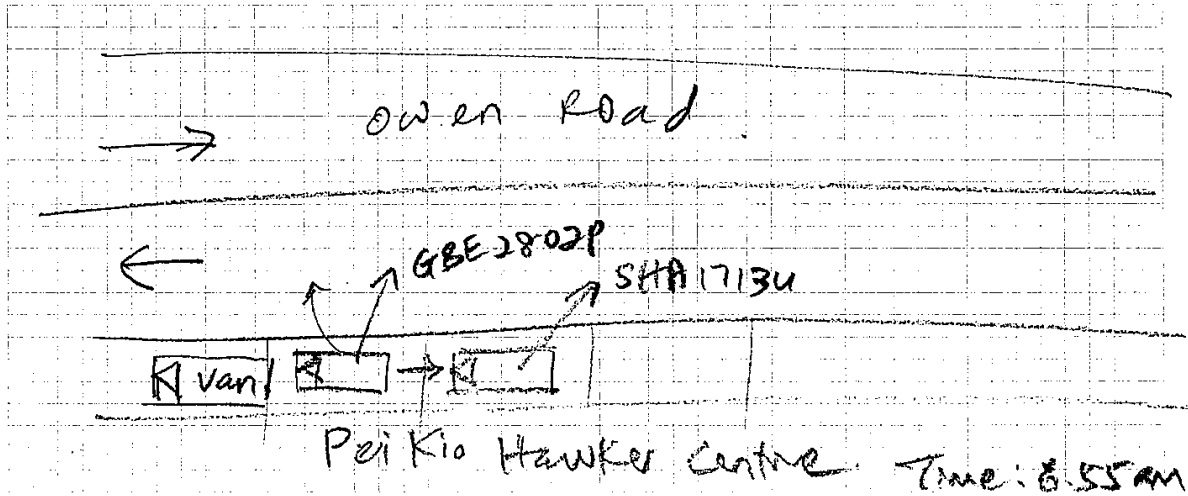

My vehicle back portion no damage.

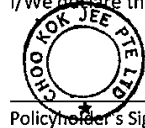
I want to state also the weather quite dark during that time.
